T E N D E R N O T I C E

Sealed Tenders on plain paper with samples are hereby invited from registered Firm/Agents/Dealers/Manufacturer for supply of various police clothing items as per list enclosed herewith at Annexure-I for Mizoram Police for the year 2012-2013 under the following terms and conditions.

TERMS & CONDITIONS :-

- 1.** The tender should be submitted to the Director General of Police, Mizoram, Aizawl on or before **5th .Sept.2012 @ 12.30PM** and will be opened on the same day at 1:00 PM.
- 2.** The tender should be superscripted on the cover as **‘TENDER FOR SUPPLY OF UNIFORM ITEMS FOR MIZORAM POLICE’** written clearly in block letters. It should be addressed to **‘Director General of Police, Mizoram, Aizawl’**.
- 3.** Rates for each item should be quoted both in figures and in words and also should mention Manufacturer/Company Trade Mark. In case of over writing/correction, the tenderers should give initials with date without which the tender will be summarily rejected. Tender once submitted shall be final.
- 4.** All tribal tenderers should submit valid **VAT Registration Certificate**, valid **House Tax Payee Certificate**, **Professional Tax Clearance Certificate**, all Non-Tribal tenderers should submit a **Court Fee Stamp** worth Rs.7.50p, valid **Income Tax Clearance Certificate/Sales Tax Clearance Certificate**. Copy of document, **not attested by gazetted officer will be considered invalid**.
- 5.** A sum of Rs.2,000/-(Rupees two thousand) only for Tribal Tenderer and Rs.5,000/-(Rupees five thousand) only for Non-Tribal Tenderer should be deposited at any Recognized Bank as **Earnest Money** in the form of Deposit at Call duly pledged in the name of Director General of Police, Mizoram and the same should be submitted along with the tender.
- 6.** Sample(s) should be submitted with tickets firmly attached containing the following information :-
 - 1) Name of Item.
 - 2) Name and address of the Tenderer.
 - 3) Price of item (both in figure and in words).
 - 4) Manufacturer/Company Trade Mark.
 - 5) Original copy of Tender Notice.
- 7.** Samples for Cloth item should be at least 50cm in length with width in full and should bear Manufacturing Trademarks.
- 8.** QUOTATION WITHOUT SAMPLE WILL NOT BE ENTERTAINED. Sample will be returned to the tenderer(s) only after completion of proceedings by order of competent authority. The rejected sample(s) must be collected by respective

tenderer(s) within 15(fifteen) days from the completion of proceedings after which the department will not be responsible for any loss or damage.

9. Rate must be FOR Aizawl inclusive of all taxes and cost of transportation/freight charge if any up to Police Central Store. The rate quoted by the tenderer will be valid for one year from the date of issue of supply order and it will be binding on the part of the approved tenderer to supply the approved item to Police Central Store, Aizawl within the validity of the rates. Increasing/revising of rate(s) within its validity period will not be permitted in any case whatsoever.

10. The undersigned reserves the right to accept or reject any or all tenders and is not bound to accept the lowest rate or any workable rates in view of the prevailing local market rates without assigning any reason thereof.

11. The undersigned further reserves the right to increase or reduce the quantity to be supplied by the approved suppliers even during the validity of the supply order according to the exact requirement of the Department. The selected tenderer should be in a position to supply the required items within a period of 120(one hundred and twenty) days from the date of placing supply order or within a specified period fixed by the undersigned in the supply order.

12. The successful tenderer will have to deposit security money by means of call deposit from the recognised bank to the extent of 2% of the value of the expected purchase of article. Contract agreement for supply of article shall be signed before the commencement of supply. This Department will not, in any way, be responsible for any financial commitment undertaken by the tenderer with the manufacturer or other services for affecting their supplies within the period from the date of provisional acceptance of the tender upto the date of issue of formal supply order by this Department.

13. Supply items must conform to the approved sample(s) in terms of quality, make, type, size etc. or as prescribed by the Director General of Police, Mizoram. In case the supplied items did not conform to the approved samples or if the items are not supplied fully within the stipulated time, Security Deposit will be liable to be forfeited to the Government.

14. In the event of rejection due to manufacturing defect or inferior quality of the article supplied resulting in shorter life of the article, fading, declining or in case of neglecting or delaying to supply in contrary to the terms and conditions, the Director General of Police, Mizoram will be at liberty to make local purchase by means of Spot Quotation or select the next higher from among the tenders. The Security Deposit will normally be returned to the supplier concerned after being satisfied that no manufacturing defects, inferiority in quality have been detected.

15. If the approved supplier fails to supply the quantity required by the Department as shown in the agreement/supply order within the stipulated time, the supplier shall be liable for being BLACK LISTED and FORFEITURE OF SECURITY DEPOSIT to the Government of Mizoram.

16. In case, the tenderer, on being selected does not personally deliver the article but send them through transport etc., the Department will not be responsible for collection of the articles from transport agency and any other shortage/damage resulting therein.

17. In case of rejection of any articles of supply sent by out-station suppliers, the Mizoram Police will not be responsible for sending them back. The rejected articles should be collected by the concerned supplier at their own cost within 15(fifteen) days from the date of issue of Rejection Notice. The Mizoram Police will not be responsible for any loss etc. of the articles kept in Police Central Store if

not collected within 15 days after rejection. The same case would also be applied to the local suppliers.

18. All Suit/ Claims for damage and disputes etc. arising out of this contract shall be decided at Aizawl only.

19. Earnest Money shall be released immediately after final selection of tenderer except for the successful tenderer which will be released only after signing of an agreement and realization of Security Deposit(shown in Sl.12 above). In case if the selected tenderer withdraw herself/himself without signing the agreement, their Earnest Money deposit shall be forfeited to the Government.
