3. State Bank of India emaw bank dang i account hawnna bank aṭanga rawn call che ni awma in sawi an awm chuan i ATM number emaw PIN emaw a hnung lama inziak emaw Password emaw pawh hrilh lovang che. Bank reng reng hian an customer-te phone in an be ngai lo tih hre reng ang che.

A rawn thawn lui che ni anga a insawi a nih phei chuan inbumna a ni tih hre nghal la, sum engmah a tlanchhuahna tur in pe hek suh ang che.
