

POSITIVE STORIES / GOOD WORKS BEING DONE IN MAMIT DISTRICT SUCCESSFUL INVESTIGATION OF ARSON CASE BY KAWRTHAH PS:

CASE REFERENCE:- Kawrthah P.S. Case No.23/2017 dt.12.11.2017 u/s 436 IPC.

GIST OF FIR:-

On 12.11.2017, a W/FIR was lodged by Lalrawnliana s/o Kaphnuna of Zamuang village stating that on 12.11.2017 at around 12:30 Am, his bike MZ-08-2899 (Karizma Black colour) along with another one bike MZ-01F-8516 (Karizma Black Colour) and one Scooty MZ-01H-2064 (Brown Colour) both were belonging to Pu V.Zoramsanga of Upper Republic, Aizawl which were parked inside the corridor of CHC, Kawrthah Main Centre building were burnt down by unknown miscreants. The fire also caused damages to the ceiling tiles of the building. Total value of the damaged two wheelers amounted to Rs. 1,65,900/- approximately. The complainant, therefore, requested to detect and take legal action against the culprit.

The case was registered and SI H.Lalengliana of Kawrthah PS was entrusted to take the case investigation.

Action taken in the investigation:-

It was suspected that some miscreants actually involved in the incident with intention of causing damage by fire. Hence, all needful steps had immediately been taken for detection of the case. The IO had carefully examined the PO and all available witnesses and as many as six suspected persons were carefully examined during the course of investigation. Local leaders and secret sources were engaged for detection of the case.

Detection and arrest of accused:-

On 22.2.2018, specific information was received from sources that one person namely Lalzarmawia (28) s/o Lalthlengliana of Kawrthah Damdawiin Veng was leaving Kawrthah town since the middle of December, 2017 and was reportedly staying at Sihphir Aizawl District. In pursuance of the information, requisition had been made to Bawngkawn PS. As requested, the suspect i.e Lalzarmawia (28) was apprehended on 23.2.2018 by Bawngkawn PS. During interrogation. Lalzarmawia (28) confessed and admitted his involvement in the case. He was, therefore, arrested on the same day i.e 23.2.2018 and he was brought to Mamit and forwarded to CJM, Mamit on 28.2.2018 with a prayer to remand him into judicial custody. Charge sheet is being prepared and submitted by the IO.

SEIZURE OF 2060 NOS. OF AK-47 (7.62 mm) LIVE AMMUNITION

BY WEST PHAILENG POLICE

CASE REFERENCE:- W.Phaileng PS C/No.6/18 Dt.26.3.2018 u/s 25(1AA) Arms Act r/w 34 IPC.

Brief story of the case:-

On the night of Dt. 25.03.2018 acting on specific intelligence input, a team of West Phaileng Police led by PuZarzoliana, SDPO, W.Phaileng recovered and seized 2060 (two thousand and sixty) numbers of live ammunitions from the illegal possession of two persons namely (i) **Vanramthanga (42) S/o K. Saikhupa of Tlabung, Lunglei District** and (ii) **D. Lallaizauva (26) S/o D. Lalthangliana of Hunthar, Aizawl**. The two suspected were intercepted at the outskirts of Dapchhuah on the night of Dt.25.3.2018 at around 9:45 p.m. while they were proceeding toward Bangladesh by availing motorcycle B/R. No. MZ-01-P-9795. The two suspected arms smugglers along with their motorcycle and 3 (three) rucksacks were brought to YMA Hall, Dapchhuah. Checking was conducted in presence of reliable witnesses from Dapchhuah village. During the checking, 2060 (two thousand and sixty) numbers of live ammunitions of AK-47 (7.62 mm) were recovered and seized from the possession of the two armed smugglers. The estimated cost of the seized ammunitions was about Rs. 1,277,200/- approximately.

The two accused persons were brought to West Phaileng Police Station and they were thoroughly interrogated. The accused persons were properly arrested and a case vide **West Phaileng Police Station Case No.6/2018 Dt.26.3.2018U/s 25 (1AA) Arms Act r/w 34 IPC** had been registered and SI Lalsangbera Sailo, Officer-In-Charge, West Phaileng PS was endorsed to investigate the case.

Conclusion:-

The case is under investigation. The two accused persons were forwarded to CJM, Mamit with a prayer to remand them into judicial custody and they were detaining in District Jail, Mamit.

MONTHLY RETURN OF GOOD STORIES OF CHAMPHAI DISTRICT POLICE

On 5.2.2018, a written FIR was received from Inspr. JH Sanghmingthanga to the effect that on the evening of 3.2.2018 @ 6:20pm, one suspected lady Lalhriatpuii (30) d/o Ricky Laldawngliana of Khawzawl Electric veng was found possessing illegal substance at Zokhawthar Police Check-gate and recovered 11 grams of heroin worth Rs.25,000/- from her possession. The accused managed to get hold of the seized item while being brought to Champhai-PS and threw it all away the seized substance. Hence, CPI-PS C/NO.11/18 DT.5.2.18 U/S 21 (b) ND&PS ACT R/W 201 (c) IPC.

On 21.2.2018 a written FIR was submitted by SI Jerry LD Poonte of Champhai PS to the effect that on 20.2.2018 they received information that some miscreant (s) were carrying large quantity of illegal contraband from Hnahlan to Champhai. Therefore, they conducted operation and apprehended one Hmangaihkimi (34) w/o Lalremruata of Hnahlan village at Bethel veng at about 1:30pm with dry leaves suspected to be Ganja which were packed in three cardboard boxes weighing 31kgs worth about Rs. 1,55,000/-. The suspected Ganjas were seized by following all formalities in presence of witnesses and conducted interrogation. On interrogation, the accused revealed that the contraband was sent by Tuanzadala of Tuimang village, Myanmar who fled away to Myanmar. The reason of delaying lodging of FIR was that the main owner of they contraband was search by the police but in vain . Hence, CPI PS C/No. 15/18 dt. 21.2.2018 U/s 20 (b) (ii)(C) ND & PS Act

On 22.2.2018, a written FIR was submitted by SI Lalsangliana to the effect that on 22.2.2018 @2:00 PM, a telephonic information was received from Khankawn Police Check Gate that while performing checking of vehicles to and fro at Khankawn Police Check Gate, one vehicle BR/No. MZ-02/A/5102 driven by Vanlaltawka(19) s/o Thangtinsuma of Champhai Vengthar was halted on suspicious ground suspected to conceal illegal substance on their vehicle. Hence, his party rushed to the spot to enquire the matter. Search was conducted after preparing grounds of believe and other necessary papers. Upon thorough search, 38 soap cases weighing 450.8 grams containing brown powder suspected to be Heroin (No-4) excluding the weight of each concealment value of Rs. 19,00,000/- was recovered and seized from the illegal possession of Vanlaltawka(19) s/o Thangtinsuma of Champhai Vengthar in the presence of reliable witnesses. The accused person alongwith the seized articles were forwarded to Champhai Police Station for further interrogation. On further enquiry, it was found that the seized

items belong to Lallawmsanga (32) s/o C. Sangzuala of Champhai Vengsang P/A Zuangtui, Aizawl who is being collected from Bawngkawn Police Station. Hence, CPI PS C/No. 16/18 dt. 22.2.2018 U/s 21 (C)/25/29 ND & PS Act.

On 22.2.2018, a written FIR was submitted by SI Zoremsanga stating that on 22.2.2018, telephonic information was received from Khankawn Police Check Gate that they detained one lady who was suspected to be carrying contraband items while conducting random checking. Therefore his party rushed to the spot after obtaining permission for arrest of a lady after sunset and after obtaining all formalities. On reaching the spot, C/39 H. Lallianmawii conducted search by observing all formalities and brown powder suspected to be Heroin (No- 4) weighing 74.7 grams worth about Rs. 2,50,000/- were recovered from the possession of Lalremsangi (35) d/o Lalnuntluanga of Zohmun P/A Zemabawk, Aizawl which were seized in presence of reliable witnesses. Hence, CPI-PS C/No. 17/18 Dt. 22.2.2018 u/s 21(B) ND&PS Act

GOOD WORK REPORT OF LUNGLEI DISTRICT POLICE

1. LAW & ORDER:

With the objective of prevention of crime and maintenance of public peace and tranquility, Late Night Patrolling has been carried out regularly.

2. CRIME SCENARIO:

During February, 2018 33 nos. of cases were registered within Lunglei District out of which 13 cases were detected and 24 cases were charge-sheet and 4 cases was final report in the same month.

3. TRAFFIC COMPOUNDING:

Regular mobile checking and effective control and regulation of traffic have greatly prevented vehicular accident in Lunglei District. On every holidays including Saturdays and Sundays and also during night time mobile checking of vehicles was conducted in Lunglei town and sometimes outside the town which had ensured the safety of pedestrians and also reduce road accidents. The traffic compounding fine realized upto February /2018 is ₹ **55,900/-**

4. On 9.2.2018 Pu Mukesh Kumar Meena IPS, DGP, Mizoram visited DIG(SR) Office, 2nd Bn. MAP Hqrs, Luanmual, Lunglei and SP's Office, Lunglei and held Samelan at SP's Conference Hall, Lunglei. 6. STOLEN PROPERTY RECOVERED:-

Stolen property recovered is ₹ **326,030/-**
