## MONTHLY RETURN OF GOOD STORIES TO BE UPLOADED IN MIZORAM POLICE WEBSITE FOR THE MONTH OF JULY, 2019

- 1. On 03.7.2019 a suo moto FIR was received from SI VL Chama Ralte stating that on dt.03.7.2019 at 4:00pm, while he was on duty at Champhai-PS, a telephonic information was received from Special Narcotic-PS, Aizawl who conducted random checking in between Champhai and Zokhawthar road and checked one vehicle taxi 800 B/R No.MZ 04 7492 plying from Zokhawthar to Champhai driven by Lalremruata (23) S/o Laltlanmawia of Ruantlang village. They detained one of the passenger name Neihlianthanga (32) S/o Bawihkiana of Ruantlang village with his luggage at Hringlangtlang junction near Mualkawi village who was suspected to be carrying some contraband items. Accordingly, he along with party rushed to the spot and conducted checking by preparing ground of belief in presence of two civil witnesses. Upon thorough checking, eleven soap cases containing brown powder suspected to be heroin weighing 137 grams value of Rs.5,50,000/- (approx.) in local market were recovered from the illegal possession of Neihlianthanga (32) S/o Bawihkiana of Ruantlang village. Hence, CPI PS C/No. 68/19 dt. 3.7.2019 U/s 21 (b) ND & PS Act was registered.
- 2. On dt. 6.7.2019, a written Suo moto FIR was received from SI Zirthanga Pachuau, Sector Officer, CID (SB) Champhai that on 6.7.2019 at 5:20am a joint group of CID (SB) Champhai, Champhai Police and Special Narcotic PS Staff, Aizawl conducted random checking of vehicles at Hringlangtlang junction at Zokhawthar road in between Mualkawi and Melbuk village, one pulsar bike B/R No. Mz-01G- 9528 plying from Zokhawthar to Champhai driven by Samuel Vanlalthaa of Melbuk Village was halted and checked on suspicious ground. After thorough checking, four soap cases containing brown powder weighing 56.6grams value of Rs. 2 Lakhs was recovered from the illegal possession of one of his pillion rider Lalrinmuani (43) d/o SL Thanga of Zemabawk (Mellimual), Aizawl. All legal formalities are observed and it was found that the said bike rider has no involvement and he was set free from the liability of the case. Hence, CPI PS C/No.69/19 dt. 6.7.2019 U/s 21 (b) ND & PS Act was registered.
- 3. On On dt. 6.7.2019, a written Suo moto FIR was received from SI Zirthanga Pachuau, Sector Officer, CID (SB) Champhai that on 6.7.2019 at 5:45am a joint group of CID (SB) Champhai, Champhai Police and Special Narcotic PS Staff, Aizawl conducted random checking of vehicles at Hringlangtlang junction at Zokhawthar road in between Mualkawi and Melbuk village, one Mahindra 207 B/R No. Mz-04A-- 0523 plying from Zokhawthar to Champhai driven by Gospel Vanlalliana S/o K.Lalpiangthara of Bulfekzawl village was halted and checked on suspicious ground. After thorough checking, 20 (Twenty) soap cases containing brown powder weighing 288.8grams value of Rs. 10 Lakhs was recovered from the illegal possession of one of his passenger Immanuela (39) S/o Lalsangliana of Tuilian village, Churachandpur Dist, Manipur All legal formalities are observed and the said 207 driver has no involvement and he was set free from the liability of the case. Hence, CPI PS C/No.70/19 dt.6.7.2019 U/s 21 (C) ND & PS Act was registered.
- **4.** On dt. 6.7.2019, a written Suo moto FIR was received from SI Zirthanga Pachuau, Sector Officer, CID (SB)Champhai that on 6.7.2019 at 8:50am a joint group of CID (SB) Champhai, Champhai Police and Special Narcotic PS Staff, Aizawl conducted random checking of vehicles at Hringlangtlang junction at Zokhawthar road in between Mualkawi and Melbuk village, one Maxi Cab (Sumo) B/R No. Mz-01K-- 4503 plying from Zokhawthar to Champhai driven by Vanramngaia S/o Sanghmingliana of Buang Village was halted and checked on suspicious ground. After thorough checking, 2 (Two) soap cases containing

brown powder weighing 24.16grams value of Rs. 1(one) Lakh (Approx) was recovered from the illegal possession of one of his passenger Vanlalpeka (20) S/o K.Lalruatfela (L) of Sakawrtuichhun, Aizawl. All legal formalities are observed and the said 207 driver has no involvement and he was set free from the liability of the case. Hence, CPI PS C/No71/19 dt. 6.7.2019 U/s 21 (b) ND & PS Act was registered.

- 5. On 09.7.2019 a suo moto FIR was received from SI VL Chama Ralte of Champhai PS stating that on dt.09.7.2019 was joint operation of random checking of vehicles conducted by Champhai Police, CID (SB) Champhai and Special Narcotic PS Aizawl at Hringlangtlang junction which was located at the outskirt of Mualkawi village. During checking, one Taxi B/R No. MZ 01 F 6757 driven by Lalthanmawia (25) s/o Sapzakhuma (L) of Bethlehem, Aizawl plying from Zokhawthar to Champhai Side was checked after preparing grounds of belief. Upon thorough checking of the said vehicle and its passengers ten soap cases containing brown powder suspected to be Heroin weighing 135 grams value of Rs. 5,00,000/- approx in local market were recovered from the illegal possession of Khawlneihmawii (44) D/O Tlangsailova of Chhim luang village, Kolasib Dist. Which was kept inside black rakshack. Hence, CPI PS C/No. 74/19 dt. 9.7.2019 U/s 21 (b) ND & PS Act was registered.
- 6. On 09.7.2019 a suo moto FIR was received from SI VL Chama Ralte of Champhai PS stating that on dt.09.7.2019 was joint operation of random checking of vehicles conducted by Champhai Police, CID (SB) Champhai and Special Narcotic PS Aizawl at Hringlangtlang junction which was located at the outskirt of Mualkawi village. During checking, one Maxi cab B/R No. MZ 04 F 2962 driven by Lalthakunga (20) s/o Zalingthanga of Zokhawthar plying from Zokhawthar to Champhai Side after preparing grounds of belief. Upon thorough checking of the said vehicle and its passengers eight soap cases containing brown powder suspected to be Heroin weighing 118 grams value of Rs. 4,00,000/- approx in local market were recovered from the illegal possession of Liansanga (70) s/o Phunsanga (L) of Dinthar, Champhai Which was kept inside a fowl cage. Hence, CPI PS C/No. 75/19 dt. 9.7.2019 U/s 21 (b) ND & PS Act was registered.
- 7. On 14.7.2019, ASI C.Zohmingliana submitted a sou-moto FIR stating that on 14.7.2019 while he was on duty at Champhai PS, a telephonic information was received from Chalbawia Junction, Police Checkgate that they detained one vehicle B/R Mz-06-8073 driven by Lalhmachhuana (42) S/o Sapzinga of Baktawng village on suspicious ground. In pursuance to this information ASI C. Zohmingliana and party rushed to the spot and conducted checking of the said vehicle and its passengers after preparing ground of belief. Upon thorough checking, they recovered 5 (five) polythene packets containing brown powder suspected to be Heroin weighing 70 grams value of Rs. 2,50,000/- from the illegal joint possession of the following (1)Lalhmachhuana (42) S/o Saplinga of Baktawng Village (2) Simon Lalruatfela (26) S/o Lalzuiliana of Khumtung village (3) Lalthanmawia (38) S/o R.Lalnunmawii of Baktawng Village. Hence, CPI PS C/No. 76/19 dt. 14.7.2019 U/s 21 (b/29/25 ND & PS Act was registered.
- **8.** On 15.7.2019 a suo moto FIR was received from ASI C. Zohmingliana of Champhai PS stating that on dt.15.7.2019, Champhai PS Staff and CID (SB) Champhai conducted random at New Champhai and recovered 6 soap cases containing brown powder suspected to be Heroin weighing 176 grams value of Rs. 6,00,000/- from the illegal possession of Lalthluaii (56) d/o Kaphnawka (L) of Mualkawi village P/A Bawngkawn Aizawl who claim herself as the owner. The said contraband was seized in presence of reliable witnesses by preparing seizure memo. Hence, CPI PS C/No. 77/19 dt. 15.7.2019 U/s 21 (b) ND & PS Act was registered.
- 9. On 15.7.2019 a suo moto FIR was received from ASI C. Zohmingliana of Champhai PS stating that on dt.15.7.2019, Champhai PS Staff and CID (SB) Champhai conducted random at the outskirt of Ruantlang village and recovered 3 soap cases containing brown powder suspected to be Heroin weighing 42 grams value of Rs. 1,50,000/- from the illegal possession of Lalthanzauvi (44) d/o Chawngchhunga (L) of Bethel veng, Champhai who claim herself as the owner. The said contraband was seized in presence of reliable witnesses by preparing seizure memo. Hence, CPI PS C/No. 78/19 dt. 15.7.2019 U/s 21 (b) ND & PS Act was registered.
