The quotation will be opened on the same date at **1:00 P.M.** The tenderer or their representatives may be present at the time of opening of the tender, if they so desire:-

1	Labrador Retriever	4	<ul style="list-style-type: none">a. The pup should have good body configuration.b. The pups of Labrador Retriever or German shepherd (Alsatian) breeds only will be procured.c. The pup should be of pure pedigree.d. The pup should be with class 'A' certificate.e. Pup should be free from any infections/contagious disease and should reflect true breed-characteristic. (Certificate should be attached which is certified by Government approved/registered Veterinary Doctor from any Government Veterinary Hospital.f. Pedigree is normally maintained up to 4 generations. Both parents should be registered with a registered Kennel Club.g. Pups should be alert, active, lively and curious.h. Eyes should be bright, clear and free from Lachrymatory inflammation.i. Nose should be free from any nasal discharge and clean.j. Ears should be clean with no loss of hairs and should not emit foul odour.k. Skin should not dry and scaly and should be free from any inflammation or eruptions.l. Body coat should be lustrous, glossy and clean.m. Pulse, respiration & rectal temperature should be recorded.n. Faeces and Urine should be normal.o. Age of pups should be 06 - 09 months at the time of delivery.

TERMS AND CONDITIONS

1. The quotation should be superscripted on the cover as **‘TENDER FOR SUPPLY OF DOGS FOR MIZORAM POLICE’** written clearly in block letters. It should be addressed to **‘Director General of Police, Mizoram, Aizawl’**.
2. 2% of the total value of the tendered quantity, calculated at the rate quoted, should be deposited by tenderer to any bank recognized by the Govt, of Mizoram as earnest money in the form of deposit at call duly pledged in the name of Director General of Police, Mizoram and the same should be submitted along with the tender.
3. The tenderers should indicate clearly the name of the breed. The price of the items quoted should be inclusive of all taxes and should be written **in figures and in words**. Signature of tenderers should be put on every pages of the tender and in case of any over writing/correction, the tenderer should give initial with date.
4. Registration Certificate with Kennel Club of India and Class ‘A’ Certificates for the pups should be attached in the tender.
5. The approved supplier shall deliver the dogs at National Training Center for Dogs, BSF Academy, Tekanpur, Jhansi Road, Gwalior, Madhya Pradesh in between dt 04.09.19 and 06.09.19 during office hours.
