MONTHLY RETURN OF GOOD STORIES TO BE UPLOADED IN MIZORAM POLICE WEBSITE FOR THE MONTH OF OCTOBER, 2019

- 1. On dt 1.10.2019, a written FIR was received from SI. Zirthanga Pachuau of CID (SB) stating that on 1.10.2019 a join party of CID (SB) and Champhai PS staffs conducted random checking at Zokhawthar road at the outskirt of Mualkawi village. At around 6:00pm, one vehicle Mahindra (Supro) B/R No. MZ-04 A-1743 driven by the owner of the vehicle Robuaia (48) s/o Sangzuna (L) of Venglai, Champhai plying from Zokhawthar towards Champhai was halted on suspicious ground. Thorough checking was conducted upon the said vehicle and found 24 soap cases containing brown powder weighing 324.6 grams suspected to be Heroin value of Rs. 12 lakhs (Approx) in local market which was concealed inside the front bamper grill of the vehicle. After observing all formalities, the said drugs was formally seized from the said driver and the owner of the vehicle Robuaia (48) s/o Sangzuna (L) of venglai, Champhai as he claimed himself as the owner of the said drugs. Hence, CPI-PS C/No.101/19 dt.1.10.19 u/s 21 (c) /25 ND & PS Act was registered.
- 2. On 2.10.2019, a suo moto FIR was submitted by SI. VL. Chama Ralte of Champhai PS stating that in pursuance to the information (after interrogation) received from the accused Robuaia (48) s/o Sangzuna (L) of Venglai, Champhai (CPI-PS C/No.101/19 dt.1.10.19 u/s 21 (c) /25 ND & PS Act), SI. VL. Chama Ralte and party with CID (SB) conducted house search of the said accused. After thorough search, they recovered 30 soap cases containing brown powder suspected to be Heroin weighing 348.9 grams value of Rs. 15 lakhs which was concealed inside the store room of the basement of the house. Hence, CPI-PS C/No.102/19 dt.2.10.19 u/s 21 (c) ND & PS Act was registered.
- 3. On 3.10.2019, a suo moto FIR was submitted by SI. VL. Chama Ralte of Champhai PS satting that in pursuance to the information (after interrogation) received from the accused Robuaia (48) s/o Sangzuna (L) of Venglai, Champhai who have already arrested and police remanded in connection with CPI-PS C/No.101/19 dt.1.10.19 u/s 21 (c) /25 ND & PS Act and CPI-PS C/No.102/19 dt.2.10.19 u/s 21 (c) ND & PS Act, SI. VL. Chama Ralte and party with CID (SB) proceeded Zotlang, Champhai to conduct house search at the residence of Lalhmunsanga (26) S/o Zosanglura of Zotlang, Champhai. After thorough search by preparing ground of bilief (U/S 50 ND & PS Act), they recovered 10 soap cases containing brown powder suspected to be Heroin weighing 122 grams value of Rs.5,00,000/approx in local market which was concealed under their house from the joint possession of Lalhmunsanga (26) S/o Zosanglura of Zotlang, Champhai and Zorampari W/o Vanlalchhuana (L) of Zotlang, Champhai. Hence, CPI-PS C/No.103/19 dt.3.10.19 u/s 21 (b)/25/29 ND & PS Act was registered.
- 4. On 10.10.2019 at around 1:00am, a written FIR was received from HC Sainguri of Champhai PS stating that on 10.10.2019 at 1:00am, while conducted checking of vehicles at Chalbawia junction police checkgate, one Auto Rikshaw B/R No. Mz-04-5609 driven by Hmangaihtluanga (24) S/o Lalthantluanga of Electric veng, Champhai plying from Champhai to Khawzawl was detained on suspicious ground and conducted checking, they recovered 200 packed of BEDC about 150 litres

- (Myanmar Alcohol) valued of Rs. 1,00,000/- (Approx) in local market. Hence, CPI PS C/No. 108/19 dt.10.10.2019 U/s 6(1)/7(3) MLPA was registerd.
- 5. On Police Commemoration Day (21.10.2019), Champhai Police organized Blood Donation at the Conference Hall of Champhai Police Station. Staff of District Hospital Champhai received bloods and 19 (Nineteen) personnel including Superintendent of Police Champhai and Additional Superintendent of Police Champhai donated their blood.
- 6. Awareness campaign on drug trafficking and abuse was conducted at the following three villages 1) At Leithum village on 2.10.2019 about 100 students and local people attend the campaign, 2) At Zokhawthar village on 10.10.2019 about 47 students and local people attend the campaign and 3) At Hnahlan village on 16.10.2019 about 500 students and local people attend the campaign.
- 7. Pu Rengkhuma of Vaphai village, Champhai District was awarded DGP's Cash Reward amounting to Rs.5000/- (Rupees five thousand) only in recognition and appreciation of his voluntary assistance to police leading to the rescue of 8 (eight) Rohingyas minor girls who were victim of human trafficking on 15.6.2019.
