He natna symptom (lan chhuahdan) nia sawi hritlang leh awmna pawh a nei lova, khawchhak (Singapore) lam atanga lo haw a nih avangin Doctor ten enfiah an duh a, chutih chhung chuan amah pawh pawn chhuak hrih lo turin thurawn an pe a ni. Coronavirus hi a kai tihna a ni lova, a zinna ram avanga en dik ngaia hriat a nih vang chauh a ni.

Amidst the current situation on COVID-19 where the public are in a state of suspense and fear, on 9th March 2020 (Monday), there was a Social Media Whatsapp post stating that "A person closely known to me working in Health Department (Civil Hospital) informed me that there was a confirmed Covid-19 case in Aizawl. I am warning my friends and relatives to be very careful" and also, "Breaking news - there's a Covid-19 suspect at ITI Veng Aizawl who recently returned from Singapore. He/she resisted to be referred to Referral Hospital, Falkawn, but forcefully admitted at around 3:00PM". This message created a state of panic among the public and Mizoram Police acted immediately to verify the rumour.

The alleged suspect was traced and found to be a 31 year old lady who went to Singapore on 14th October 2019 and returned to Mizoram on 2nd March 2020. On her way home, she was screened at both Kolkata and Lengpui Airport and was cleared of any symptoms of the virus. Even though she does not have any symptoms of the virus like cough and cold, since she recently returned from Singapore, the doctors would like to monitor her and advised her to keep indoors for some time. This does not mean that she had contracted Coronavirus but just because she recently returned from abroad and need to be monitored.

Posting of unconfirmed rumours which can create panic and fear among the general public is a very serious issue and those responsible for the social media posts (11 persons) have been identified and arrested and a criminal case vide Vaivakawn PS Case No.54/2020 Dt.10.3.2020 u/s 505 (1)(b) IPC has been registered against them . The charge section is noncognizable, cognizance has been obtained from the Chief Judicial Magistrate, Aizawl. Apart from those arrested, the other persons involved in this case are being investigated and legal action will be taken against them.
