

## GOOD STORIES FOR THE MONTH OF MAY, 2020

1. On 21.05.2020 a suo moto FIR was submitted by St Joseph Lalhnehzela of Champhai PS stating that while he was on duty at Champhai PS on 21.05.2020 @ 7:00 am Police on duty at Chalbawia Junction, Khankawn Police Check gate produced one vehicle BR No. MZ.01/Q-1348 driven by Joseph Lalmuanpuia (27) lo Lalmuanpuia (L) of Zohnuai, Aizawl which was plying from Champhai for Aizawl on suspicious ground. Upon thorough checking of the vehicle and its occupant by preparing grounds of belief, two) soup cases wrapped in a joker pant and face towel containing brown powder suspected to be Heroin No 4, which was concealed inside the tailboard and two plastic can which was concealed inside the pocket of the driver, weighing 20 Grams in total suspected to be Heroin No. 4 and value of **Rs 90000/-** in local market was found The recovered item with the vehicle were seized in presence of reliable witnesses by preparing seizure memo. Hence, **CPI PS C/No - 42/2020 Dt 21.05.2020 U/S 21(b)/25 ND & PS.**
  
2. On 22.05.2020 a suo moto FIR was submitted by ASI C Hmingthantlanga of Champhai PS that on 22.05.2020 @ 6:30 am certain amount of suspected illegally imported five cases and 40 cartons of foreign cigarettes (Farstar) belonging to Phungthani (56) d/o Paclii of Champhai Kanan and Zonunsangi (39) vo Lalauva of Jail Veng, Champhai was recovered from bus b'r no. MZ 01T 0193 driven by Kapkima (56) s/o Lianzuala of Mission Veng Aizawl plying from Champhai towards Aizawl. The recovered material was seized in presence of reliable witnesses at Chalbawia Junction, Khankawn Police Check gate while they were intending to transport the same to Aizawl from Champhai. Total value of the seized foreign cigarettes (Farstar) is **Rs. 2,03,000/-**(approx) in local market. After short interrogation, the said driver Kapkima (56) s/o Lianzuala of Mission Veng Aizawl was set free as his involvement was not found. **Hence CPI PS CINO.44/2020 Dt 22.05.2020 U/S 269 IPC.**
  
3. On 23.05.2020 a written FIR was submitted by ASI Laltlanchhuaha of Champhai PS, stating that on 22.05.2020 at 10:15 PM while he was on duty at Champhai PS, Lalawta, MPS, SDPO Champhai produced 24 Cases of foreign cigarettes (Farstar), worth **Rs 6,00,000/-** approx in local market, belongs to Zaihmingthanga (35) do THE Ramnghinga of Electric, Champhai which was detained by Tlamsam VLTF Duty. The following persons were forwarded to CJM Court Champhai on 23.05.2020 for judicial remand.

  - 15) One labourer Juvenile in conflict with law, Malsawmdawngliana (18) Lalramzauva, Electric Veng Champhai was forwarded to Principal Magistrate Champhai. **Hence CPI PS CNo - 45/2020 Dt 23.05.2020 us 269/188/34 IPC.**

4. On 25.05.2020 a suo moto FIR was received from SI Liansangpuii of Champhai PS that on 25.05.2020 while she was on duty at CPI PS, reliable information was received that there were some illegal substances proceeding towards Champhai from Zokhawthar. In pursuance to this information, IS Liandingpuii and party rushed to the spot and @ 3:30 pm, one vehicle truck) B R/NO MZ 04 A 0532 driven by Lalrinmawia (24) s/o Lalkulha of Venglai Champhai was stopped and checked. Upon thorough checking of the said vehicle 15 cases of foreign Cigarettes (Farstar) value of **Rs. 4,50,000/-** approx in local market was recovered and seized by preparing seizure memo in presence of reliable witnesses from the said driver as he claimed himself as the owner of the seized items. **Hence, CPI PS C/No - 46/2020 Dt 25.05.2020 ws 269 IPC r/w 509) of the Mizoram (Containment and prevention of Covid -19) Ordinance 2020.**
5. On 26.05.2020 a suo moto FIR was submitted by ASI Lalchhanchhuaha CPI PS that on 26.05.2020, they recovered cases of foreign cigarettes from one vehicle B R/No. MZ-04.A.3441 at Zotlang, Champhai. The recovered cigarettes belongs to F.Remlalnghaka (37) so Lalchhuanvawra of Zotlang, Champhai. The said cigarettes along with the said vehicle were seized and the said accused person was also arrested. The total value of the said article worth **Rs. 1,80,000/-** approx in local market. **Hence, CPI PS C/No - 47/2020 Dt 26.05.2020 u/s 269 IPC /w 5(9) of the Mizoram (Containment and prevention of Covid -19) Ordinance 2020.**
6. On 26.05.2020 a suo moto FIR was submitted by ASI Lalanchhuaha of CPI PS that on 26.05.2020, they recovered 5 cases of foreign cigarettes from one vehicle B R/No. MZ-09-3030 at Selluaia Traffic Point, Venglai, Champhai. The seized cigarettes belongs to Lalrammawia (48) s/o Lallana of Seling, Aizawl District. The said cigarettes along with the said vehicle were seized and the said accused person was arrested. The total Value of the said articles worth **Rs. 1,50,000/** approx in local market. **Hence, CPI PS C/No - 48/2020 Dt 26.05.2020 u/s 269 IPC r/w 5(9) of the Mizoram (Containment and prevention of Covid -19) Ordinance 2020.**
7. On 19.05.2020, Champhai Police seized 15 Cartons of foreign cigarettes (Farstar), value of **Rs. 70000/-** belonging to Thangjohna (45) s/o Pauzaliana of Sesih, Champhai District. The seized item was suspected of illegally imported from foreign country which was recovered by volunteers duty of Leisenzo VOTE The seized item was handed over to Custom Preventive Force, Champhai on 20.05.2020.
8. On 26.05.2020, a written FIR was submitted by SI Joseph Lalhnehzela of CPI PS that they seized 8 cases of foreign cigarettes belongs to Zokapvela (30) s/o J.Lalduhthanga of Venglai Champhai which were detained by YMA duty at Ruantlang, Champhai. Zokapvela (30) of Champhai was arrested and forwarded to CJM Court Champhai. The total value of the seized article worth **Rs. 96,000/-** approx in local market. **Hence, CPI PS C/No - 50/2020 Dt 26.05.2020 u/s 269/188 IPC r/w 5(9) of the Mizoram (Containment and prevention of Covid -19) Ordinance 2020.**
9. On 06.05.2020, a written FIR was received from ASI David Lalthapuia of Zokhawthar PS to the effect that in pursuance of reliable information received, Zokhawthar Police along with YMA Branch Zokhawthar duty conducted joint operation on the night of 05.05.2020 @ 1:00 am and seized white and brown powder suspected to be heroin No. 4 kept in 24 soap cases and some quantity kept inside empty grand royal container and detol container total weighing 328 grams) value of **Rs. 480000/-** approx in local market with 9000 tablets of Methamphetamine (weighing 960 grms) value of **Rs. 450000/-** approx in local market were recovered from the illegal possession of Lalchungnunga (32) s/o Thatnawla of Zokhawthar, Vanapa Section. The said white and Brown powder suspected to be No.4 and Methamphetamine kept in black Polythene were found from his residence as well as near his residence. **Hence, Zktr PS C/No.6/20 Dt.06.05.2020 U/S 21(c)/22(c) ND & PS Act.**
