TENDER NOTICE

Sealed quotations on plain paper with samples are hereby invited from registered firms/agents/dealers/manufacturers for supply of uniform items for Mizoram Police for the year 2020-2021 as per the list enclosed herewith as Annexure-I under the following terms and conditions.

TERMS & CONDITIONS:

- **1.** The quotation should be submitted with the original copy of Tender Notice to Director General of Police, Mizoram, Aizawl on or before **11:00 AM of 7.9.2020** and will be opened on the same date at 1:00 PM.
- 2. The quotation should be superscripted on the cover as 'TENDER FOR SUPPLY OF UNIFORM ITEMS FOR MIZORAM POLICE 2020', written clearly in block letters. It should be addressed to Director General of Police, Mizoram, Aizawl.
- 3. The quotations shall be in a **Two-bid system viz. 'TECHNICAL BID'** and 'PRICE BID'. The two bids shall be placed in two separate envelopes. The word 'TECHNICAL BID/PRICE BID for supply of uniform items for **Mizoram Police'** shall be prominently marked on the top of each envelope separately. Both these bids shall further be put in one envelope and sealed properly before putting in the tender box duly super scribed.
- **4.** Rate for each item should be quoted both in figures and words. Brand of the item should be mentioned in the quotation wherever relevant. Where there is an over-writing or correction, the quotationer should give his initial with date, without which the quotation will be summarily rejected. Quotation once submitted shall be final.
- 5. All tribal quotationers should enclose a certified copy of valid GST Registration Certificate and Professional Tax Clearance Certificate. All Non-Tribal quotationers should enclose a Court Fee Stamp worth Rs.7.50p, Income Tax Clearance Certificate and receipt and a certified copy of valid GST Registration Certificate. Copy of any of the documents not attested by a competent officer will be considered invalid (except system generated documents).

- **6.** 2% of the total value of the quoted quantity, calculated at the rate quoted, should be deposited by all quotationers in the form of Call Deposit pledged in the name of Director General of Police, Mizoram as Earnest Money to any of the banks recognized by Govt. of Mizoram. The call deposit should come along with the quotation. Call Deposits made by unselected quotationers will be released soon after final selection of suppliers. Call Deposits made by selected quotationers will be released only after the quotationers have made Security Deposit.
- **7.** All samples should bear the following information on labels firmly attached to them.
 - 1) Name of firm
 - 2) Name of the item.
 - 3) Sample code no.
 - 4) Brand of the item (wherever relevant).
- 5) Name of proprietor and address of the quotationer with his/her contact number .

(Without this information, the sample will be automatically rejected)

- **8.** Two (2) nos. of samples should be produced by the quatationers for each item. For which one should be kept at PCS as approved sample and another to be given back to the selected quatationer for procurement from the factory.
- 9. Price of the item should not be written in the tag attached to the sample but be written in the quotation letter (both in figure and words) with sample code no.
- **10.** Evaluation of samples will be conducted before opening the quotation rate. Samples which do not meet the technical specifications and which are of inferior quality will be rejected at this stage and only the samples meeting required technical specifications and up to the mark quality will be proceeded for further selection process.
- 11. Samples for all the items should conform to the technical specifications given in the Annexure-I. Samples for the cloth items should be at least $\frac{1}{2}$ meter both in length and width.
- 12. All quotations without sample will be invalid. Samples will be returned to the quotationer only after completion of the proceeding. All rejected samples must be collected by the quotationer within 15(fifteen) days from the date of completion of the proceedings after which the department will not be responsible for any loss or damage.

- 13. All the rates must be FOR Mizoram Police Central Store, Mualpui, Aizawl, Mizoram and also inclusive of all taxes. It will be binding on the approved quotationer to deliver all the ordered items to Mizoram Police Central Store, Mualpui, Aizawl within 120 (one hundred and twenty) days from the date of issue of the supply order. Proposal for raising the rate will not be entertained in any case.
- **14.** The undersigned reserves the right to increase or reduce the quantity to be supplied even during the validity period of the supply order according to the exact requirement of the department and availability of fund. The selected quotationer should deliver the ordered item within a period of 120 (one hundred and twenty) days from the date of placement of the supply order.
- 15. The selected quotationer must make Security Deposit to a bank recognized by Govt. of Mizoram at 5% of the value of the supply order in the form of Call Deposit duly pledged in the name of Director General of Police, Mizoram and submit the same to this office. The Security Deposit will be returned to the supplier only on satisfaction of this office with the supply. The security deposit will be liable to be forfeited to the Government if the firm fails to supply the ordered item within the stipulated time and also if the firm fails to supply it fully within the stipulated time. This will also render the firm liable to be blacklisted.
- **16.** The supplied item must conform to the approved sample in all respects and sizes ordered. If the supplied item does not conform to the requirements, the Uniform Survey Board will have the right to reject them.
- **17.** In the event of rejection of the supplied item for the above reasons, Director General of Police, Mizoram will have the right to select any other suitable quotationer to supply the item.
- **18.** In case of rejection of an article from an out-station supplier, Mizoram Police will not be responsible for loss or sending it back. The rejected article should be collected by supplier at his own expense within 15(fifteen) days from the date of issue of Rejection Notice. The same will apply to all the local suppliers as well.

- **19.** Grievances arising out of this contract, if any, shall be decided in Aizawl only.
- **20.** If the selected quotationer withdraws and refrains from signing Agreement, his Earnest Money shall be forfeited to the Government.
