Cyber Crime Police Station was inaugurated by DGP Mizoram Pu SBK Singh IPS in an inauguration programme held on 27<sup>th</sup> November 2020 at 12:00 noon at Police Headquarters (PHQ), Khatla.

Cyber Crime Cell under SP CID(Crime) was established on 21<sup>st</sup> May, 2014 to tackle the rise in Cyber Crimes without creation of any additional posts. The Cyber Crime Cell was then upgraded to Cyber Crime Police Station in August, 2018. 5 (five) posts of SI(UB) for Cyber Crime Police Station has been created by the Government in 2019. In view of the the need to tackle and curb the rising cyber crimes, with the initiatives of DGP Pu SBK Singh, IPS, Cyber Crime PS started to function in May, 2020. The Police Station was formally inaugurated today by DGP. This PS has jurisdiction all over Mizoram and any person can come to lodge a complaint regarding any cyber crime at this Police Station.
