PUBLIC ADVISORY

It has come to the attention of the Mizoram Police that some individuals acting as agents of Telecom Service Providers (Airtel, Jio, etc.) are collecting photographs and ID documents (Aadhar, PAN card, Voter ID etc) in exchange for payments of a few hundred rupees. Although there is no confirmation yet on what these documents are going to be used for, it should be noted that these documents can be used to open bank accounts and/or register SIM cards in the name of the ID holder. These bank accounts/SIM cards may possibly be sold to fraudsters throughout India who may use it for fraudulent purposes, which can be traced back to the owner of the said ID.

The members of the public are hereby advised to be aware of such fraudulent activities and to refrain from selling their ID documents as it can lead to unexpected serious legal consequences.
