#### PRESS RELEASE ON COPYRIGHT INFRINGEMENT

There have been several instances of copyright violations relating to movies, music videos and other content created by our fellow Mizo artists. It has been reported that the newly released Mizo movie "Thaibawih - Hmeichhe lu chu Mipa" has been unlawfully copied and is being illegally circulated by certain members of the public. This amounts to copyright violation which is punishable with imprisonment for up to six months under Section 63 of the Copyright Act with a minimum fine of Rs.50,000/-.

Mizoram Police cautions the public to refrain from engaging in such lawful activities. Strict legal action shall be taken in case of any such violation.
