TERMS AND CONDITION


1. The quotation should be superscripted on the cover as '**TENDER FOR INSTALLATION OF INTERNAL ELECTRIFICATION AND SERVICE CONNECTION OF.... (Name of Work)**,' written clearly in block letters. It should be addressed to 'Assistant Inspector General of Police (P&L), Mizoram, Aizawl.'
2. The price of the items quoted should be inclusive of all taxes and should be written in figures and in words. Signature of tenderers should be put on every pages of the tender and in case of any over writing / correction, the tenderer should give initial with date.
3. All tribal tenderers should enclose a certified copy of GST Registration Certificate and Tribal Certificate.

4. The rate must be quoted in decimal coinage. Amount must be quoted in full rupees by ignoring up to forty nine paisa and considering more than fifty paisa as rupee one.
