SEIZURE OF ARECANUTS

Acting upon reliable information received on 07.10.2023 @ 01:40 pm, 3 (three) trucks bearing Registration No. MZ 04A 6136, MZ 04A 6219 and MZ 04A 6469, loaded with Burmese Arecanuts (299 bags), total weight estimated as 210 Quintals, valued Rs. 95,99,100 (Custom rate) were found at Uvaimual, Bairabi road via Kolasib to Bairabi. Accordingly, Burmese arecanuts were formally seized in presence of reliable witnesses from its respective truck drivers. On further thorough interrogation, it was learnt that the Burmese arecanuts were illegally imported from Myanmar (Burma) and they were transporting it from Zotlang, Champhai for Vairengte, Kolasib District; Mizoram.

All the seized Burmese Arecanuts, the said three involved vehicles with ignition keys and its drivers –

- i) Thangzatluanga (26 Yrs) S/o Roneihthanga of Tlangsam, Champhai,
 - ii) Zodingsanga (19 Yrs) S/o Thanmawia of Tlangsam, Champhai and,
 - iii) Vanlalruata (19 Yrs) S/o Laltlanlawma of Tlangsam, Champhai
- were handed over to the Deputy Commissioner, Custom Division; Aizawl on 08.10.2023 for further legal necessary action.
