HUGE SEIZURE OF CRYSTAL METH

Drugs smuggling continues to be a major cause of concern to our society and beautiful State. With a view to improve general policing as a whole and in the preparation for peaceful and smooth conduct of General Legislative Assembly Election of Mizoram, 2023, Mizoram Police has also made all out efforts in the fight against this menace, resulting in significant seizures as well.

In yet another huge success in our relentless 'War On Drugs', on the evening of 04.10.2023 at around 7:00PM, Aizawl District Special Branch (DSB) team intercepted one vehicle MZ01- 7001 (Tata Intra) at Zemabawk East and seized 11.6 Kgs of Crystal Methamphetamine worth Rs. 34 Crores from the illegal possession of Ropianga (37) s/o Lalthanga of Khawmawi, Myanmar. Bawngkawn PS case No. 676/23 Dt.4.10.2023 u/s 22 (c)/25 ND&PS Act, 1985 r/w 14 Foreigners Act, 1946 was registered for further investigation and necessary legal action.

While we are committed to supply disruption, we continuously need and seek support of the public, civil society and all other stakeholders to make all out efforts for demand reduction and in identification and apprehension of drugs smugglers/peddlers.
