**TERMS AND CONDITION OF SALE OF VEHICLE AGAINST
PUBLIC AUCTION NOTICE NO. 01/2024**

1. Interested persons/parties may submit their bid, in a PRESCRIBED FORM AND COVER (ENVELOPE) latest by 12:00 Noon of 31/01/2024. The duly sealed cover should be dropped in the Tender Box kept at Personal Branch of Asst. Inspector General of Police (P&L), Police Headquarters, Khatla, Aizawl. The outer cover of the envelope should be super-scribed as:


“QUOTATION FOR AUCTION VEHICLE NL21/2702(HGV)”

2. Tender Form shall be signed in ink/ball point pen by tenderer or the authorized signatory only, Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
3. Quotation should be free from correction, overwriting, using correcting fluid. If the case arises, overwriting or correction should be initialed by the bidder.
4. The sale of vehicle shall be strictly on “as is where is basis” and no guarantee or certificate of its worthiness or quality will be given by the Police Headquarters. The condition of the vehicles can be inspected physically.
5. Reserved price is fixed at ₹ 43,000/-. Bid amount below this reserved price will not be accepted.
6. Earnest money is fixed at Rs 4500/- which the quotationer should deposit in the form of Deposit at Call in favour of DGP Mizoram in any Schedule Bank which will be forfeited if the quotation is withdrawn. Quotation without Earnest Money will not be accepted.
7. PHQ is not bound to accept the highest bid. The successful bidder should deposit the total amount of his/her bid within 15 days from selection of successful bidder, failing which his/her quotation will be rejected.

8. Earnest Money deposited by unsuccessful bidders shall be returned within 14 days of the award of the successful bidder upon submission of application for release of the same in writing addressed to The Asst. Inspector General of Police (P&L), PHQ.
9. The successful bidder shall be required to submit documentary evidence in support of residential status (Ration Card/Voters Identity Card/ Aadhaar Card/PAN Card in case of individual and registration Certificate in case of firms etc.).
10. The responsibility of Mizoram Police with regard to watch of stationed sold vehicle ceases immediately after the successful auction i.e. after payment of the bid amount to PHQ. The successful bidder has to take delivery of the auction vehicle within 2 weeks at their own expenses from the date of allotment. No assistance/transportation will be provided by Mizoram Police.
11. The successful bidder will be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost. This office will not be responsible for any lapse on this part in this regard.
12. The competent authority of PHQ reserves the right to withdraw any item and to reject any/all of the quotation fully or partially or cancel the sale of vehicle at any stage without assigning any reason thereof.
13. Any dispute over the quality and value of the vehicle put to auction cannot be entertained after auction.
14. The Police Headquarters reserves the right to accept or reject or alter any bid without assigning any reason thereof.
15. In case of any dispute with relate to auction of the vehicle, the decision of the Police Headquarters will be final and binding.
