# HUGE SEIZURE OF HEROIN AT SELESIH AREA, AIZAWL

Last night on 25.05.2024, upon receiving an information from reliable source regarding an attempted sale of heroin in Selesih area, Aizawl, a team of Aizawl District Special Branch (DSB) immediately proceeded towards Selesih, Aizawl and upon arriving at Selesih and conducting a search operation, the team intercepted one black scooter (Access) carrying two large white nylon bags near NEC Junction in Selesih. On checking the bags, they recovered and seized 311 soap cases of suspected heroin, weighing 3.547 Kgs, valued Rs.1,06,41,000 from the illegal possession of C.T Liana (25) s/o Chanbilthuan of Hmattung, Tahan, Myanmar, in the presence of two reliable witnesses. The accused was found to have no valid documents to enter India and was promptly arrested.

A case No.185/24 dt.26.05.2024 u/s 21(c)/ 25 ND & PS Act r/w 14 Foreigners Act has been registered at Bawngkawn Police Station for further investigation to trace forward/ backward linkages and for taking legal action.

With community support, the dream of 'Drugs Free Mizoram' may turn into a reality soon. Active support, cooperation and complete synergy from the public, civil society and all other stakeholders will always remain key to success in this endeavour.
