# SIGNIFICANT SEIZURE OF DRUGS, ILLICIT LIQUOR AND ARECA NUTS MADE BY MIZORAM POLICE.

The untiring drive against drugs and other illegal activities continues. Significant seizures of drugs, illicit liquor and areca nuts were made by Mizoram Police at several location as under:

1). Yesterday on 6.6.2024, Champhai PS team while conducting random checking at Chalbawia Junction Khankawn Police Check gate recovered and seized 156 soap cases of suspected heroin, weighing 1.902 Kgs (1902 grams) and valued Rs.57,06,000 from one vehicle (i-10 Car) B/R No.MZ01L-4077 driven by Lalnunpuia (42) s/o K.Lalhlira of Zokhawthar (Vanapa Section) P/A Hunthar Veng, Aizawl The contraband was concealed inside the four doors of the said vehicle. Champhai PS Case No.121/24 dt.6.6.24 U/S 21(c)/25 ND & PS Act was registered for further investigation and legal action.

2). Earlier on the night of 5.6.2024, acting on input from reliable information, Lunglei District Special Branch team recovered and seized 10 soap cases (116 grams) of suspected Heroin, valued Rs.348060 from the illegal possession of Francis Lalramthanga(42) s/o ZD Lalthlamuana of Bazar Veng, Lunglei at Lunglei Venglai area. Lunglei PS case No.110 Dt.05.06.2024 u/s 21(b) NDPS Act was registered for further investigation and legal action.

3). On the early morning of 6.6.2024, E. Lungdar Check Post duty recovered and seized 7500 Kgs/150 bags of dry areca nuts from two vehicles - MZ04A-4629 driven by Thangtinkapa of Leisenzo, Champhai District and MZ04A-6453 driven by T. Chhuanliana of Sesih Champhai District at the junction of Chhura Lung, outskirt of E. Lungdar village. The consignments were being illegally transported from Myanmar. The seized arecanuts alongwith the vehicles are being forwarded to District Magistrate Serchhip for further legal action under promulgation order issued by District Magistrate against transportation of areca nut from Myanmar.

4). On the night of 06.06.2024, Special Narcotic PS team intercepted one truck (Tata 610) B/R no. MZ04/A-6446 at Zemabawk area, seized and confiscated several cases of foreign liquors – 66 cases (1620 cans) of Beer valued Rs.4,86,000 and 23 cases (460 Bottles) of Soju valued Rs.2,53,000 from the illegal possession of three (3) persons – Tlanglawma (38) s/o Kamhleia of Chaltlang Lily Veng, Aizawl, Malsawmsangi (50) d/o Thantluanga (L) of Zemabawk East, Mel-4 Mual, Aizawl and Thahlunthanga (62) s/o Tawkhranga of Chanmari West, Aizawl. Bawngkawn PS Case No.201/24 dt.07.06.2024. u/s 6(1)/7(3) MLP Act was registered for further investigation and legal action.
