I. SECURITY

(i) The particulars of its organisation functions and duties: Security Unit deals exclusively with protection of Protected Persons, visiting Dignitaries, Manning of Raj Bhawan Security, CM Office & Bungalow Security, Civil Secretariat Security (MINECO), Secretariat Annexe & Assembly Secretariat), Lengpui Airport Security and Mualpui Helipad.

(ii) The powers nad duties of its officers and employees:

SP: He supervises and makes decision over all the branches of offices under Security Unit and all the Security arrangement in the state is made under his close supervision.

Addl. S.P: He is the D.D.O of the Unit. She supervises all the branches of Security in the making of Security arrangement, Ministerial works, enforcement of rules and regulations in the office and maintains discipline of the unit under the supervision of **S.P. Security.**

Dy.S.P.(**Hqr**): He supervises all the branches of the Unit office and arrangement of Security and VIP movement under the supervision of **S.P. Security**. Casual leave of Constable to Head Constable/Havildar is granted by him.

Dy.S.P. Airport: He supervises the Security of Lengpui Airport under the supervision of **S.P. Security**. Casual leave of Constable to Head Constable/Havildar of Lengpui Airport staff is granted by him.

Inspectors: The Inspectors of this unit are deployed as **(1) Reserve Officer** – who makes sure that everything goes smoothly by looking after the transfer and posting, leaves, training, detailment of PSOs, arrangement of Security for VIP and other dignitaries etc. under the supervision of S.P. Security. **(2) Motor Transport Officer** – who looks after all the unit vehicles, consumption of POL, detailment of drivers and men under his branch including other duties allotted to him from time to time by S.P. Security. **(3) Inspectors Lengpui Airport** – They are deployed to supervise and make sure that their sub-ordinate officers and men perform their duties normally and that the civilian and passengers are given adequate security within the terminal building of the Airport **(4) Inspector Raj Bhawan** – He is deployed to ensure the Security of the Governor and he maintains the disciplines and orders to all other sub-ordinate ranks of Security at Raj Bhawan under the supervision of **S.P. Security**. **(4) Inspector Equipment** – who looks after all the Security equipments for Bomb Disposal Squad and Anti-Sabotage Squad.

Sub-Inspectors: In Security Unit Sub-Inspectors are deployed in different branches, and their duties differ from place to place, they are also deployed at Reserve Office, Secretariat, Raj Bhawan, Lengpui Airport, Thuampui Helipad, PSO to VIP and other dignitaries etc. and they are responsible for maintenance of discipline and order to their Sub-ordinate ranks as per the chain of command.

Asst. Sub-Inspector: Asst. Sub-Inspectors of Security Unit assist the sub-inspectors and even take-over the charge of sub-inspectors during their absence. They are also deployed at, Reserve Branch, Lengpui Airport and Civil Secretariat.

Head Constable/Havildar: They are deployed as PSO to VIPs and other dignitaries and high officials, Access Control of Assembly House, Secretariat Gate, Raj Bhawan, Lengpui Airport, Thuampui Helipad in-charge of Guard, pilot and Escort, Armourer, etc. They are responsible for maintaining discipline among the NCO staff.

Naik: They are deployed as PSO to VIPs and other dignitaries, Lengpui Airport, Secretariat Gate, Raj Bhawan, even in-charge of Guard, Pilot & Escort etc. during the absence of Havildar/Head Constable.

Constable: They are deployed as PSO to VIPs and other dignitaries, Lengpui Airport, Thuampui Helipad, Guard, Pilot & Escort and any other suitable places of duty.

IV Grade: Their duties mainly concentrate on cleaning and maintaining of office sanitation and helping office staff in their duties like getting and distributing files and papers in addition to their normal duties.

(iii) The procedure followed in the decision making process, including channels of supervision and accountability:

All important decisions are taken with prior consent of Superintendent of Police, Security Unit.

(iv) The Norms set by if for the discharge of its functions:

All decisions in Security Unit are made through collective endeavors via step-by-step movement of files.

(v) The rules regulations instructions manuals and records held by it or under its control or used by its employees for discharging its functions:

The rules/regulations etc. as per Mizoram Police Manual and Security Manual are used for discharging of its functions.

(vi) A statement of the categories of documents that are held by it or under its control:

The main procedure of processing each case is done through files opened for this purpose. Therefore, documents that are held by Security Unit are mainly files.

(vii) The particulars of any arrangements that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof:

This Clause is not applicable/existence in Security Unit.

(viii) Statement of the boards, councils committees and other bodies consisting of two or more persons constituted as its parts or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public.

II. CID (SB)

(i) The particulars of its organisation functions and duties:

The organization is called Special Branch

Functions:-

- 1) The main functions of the special Branch is to promptly communicate to Government and to the Director General of Police informations on all matters of political and public importance.
- 2) The Special Branch also deals with matters of national security of individuals who are important to the nation.
- 3) Related to above the State Special Branch has to discharge other functions as follows:
 - a) to communicate to the Special Branch of others States information which is of interest to them;
 - b) to communicate to Deputy Inspector General of Police, Range and Superintendent of Police of the District and other specified officers important informations which is of interest to them.
 - c) to prepare periodical reports on matters falling within its purview and to forward copies to those specified;
 - d) to make secret enquiries into important matters of political nature or those affecting national interest;
 - e) to help in the investigation of those crimes which have a political purpose or motive and in which political suspects are involved.

Scope:- The scope of functions of the Special Branch and the subject dealt with includes the following:-

- i) Political movements and associations, their inception, progress and development this includes societies having any political purpose avowed or concealed.
- ii) Political activities, open as well as secret and subversive.
- iii) Labour Unions, their formation and development and labour activities.
- iv) Volunteer organizations and their activities.
- v) Youth movements and students associations and their activities.
- vi) Religious and communal activities and religious activities having a political complexion.
- vii) Social and economic matters having political significance.
- viii) Movements and activities of foreigners believed to be politically motivated.
- ix) Anti-national activities or those likely to affect the security and safety of the State or of India generally.
- x) Security schemes, including security of vital installations and key industries.
- xi) Movements and activities of political suspects and surveillance and watch over them.
- xii) Censorship of newspapers, periodicals, pamphlets, party literature etc.
- xiii) Loyalty and reliability of Govt. services particularly of employee in defence services, transport and communications, services charged with the maintenance of law and order and those connected with vital installations and industries.

Special Function:

The following matters are dealt exclusively by the State Special Branch:-

a) The existence of any strong and widespread popular feeling on political matters of importance.

- b) The circulation of rumours, newsletters, posters, leaflets or other publications likely to disturb the public peace or to create disaffection, communal strife or disturbances.
- c) Attempts to tamper with the discipline, performance or loyalty of the Armed Forces or of the Police.
- d) Attempts to suborn the loyalty of other services of Government.
- (ii) The powers nad duties of its officers and employees: The Sr. Superintendent of Police CID (SB) is the head of the Special Branch, subject to the general control and supervision of the DGP. He is responsible to the DGP and to the State Govt. for efficient performance of duty by the State Special Branch. He exercises full administrative control over the entire organization of the Special Branch at the State. He is authorised to send information and reports on matters which come within the purview of the Special Branch direct to the Govt. In all administrative matters, including discipline and service matters the SrSP, CID(SB) shall however, take up the matter with the DGP.

Under the administrative control of the Sr. Superintendent of Police, there are various Police functionaries starting from rank of Constable to Additional Superintendents of Police. They are governed by and exercise the powers and duties conferred by the Mizoram Police Special Branch Manual, Mizoram Police Manual, various special and minor acts which are adopted by the Government of Mizoram apart from the CCS & CCA Rules and Financial Rules.

The functions and duties of various Police functionaries under the Superintendent of Police, Special Branch are as follows:-

- (a) Addl. SP:- He is the over all in-charge of all Branches of CID(SB). All the files are routed through him by concerned Dy. SP. All the correspondences relating to Monthly, Quarterly & Half yearly return are signed by him. He is authorized to sign Contingency Bills, Pay Bills and functions as DDO. He is the in-charge of Estab. & Account Branch and DSI.
- (b) Dy.SP (Hqrs) :- He is the in-charge of Reserve Branch, Field Branch, Confidential Branch, Technical & SMAC Branch and all Sector Officers & men. He also assists Addl.S.P in compilation of DSI.
- (c) Dy.SP (Field):- He supervised day-to-day works of Field staff, all Sector officers & men. He is the in-charge of Foreigner and Passport Branch and MT Branch. He also assist Addl. SP in compilation of DSI.
- (d) Reserve Officer and other Officers with Constabulary in Reserve Office: Reserve Officer (R.O) is in-charge of Reserve Office which is one of the branches of the office of the Superintendent of Police CID(SB). He is concerned mainly with the discipline and management of the forces and manpower available in the Unit. He and his staff are responsible for maintenance of Service books of all staff of CID(SB) excluding G.Os and Ministerial staff, and also proper maintenance and custody of Office equipments and monitoring correspondences.
- (e) Motor Transport Officer: A Inspector of Police is placed as in-charge of M.T Branch. The sanction strength of driver for the Unit is 20 and is filled up at present. Their duties and responsibility are to look after and maintain the vehicles allotted to the Unit. The MT Branch is responsible for drawing of POL and issue to vehicles and taking of defective vehicles to workshop for repair.

- (f) Head Assistant (H.A): A ministerial Inspector is placed to look after all ministerial staff and deals with the general establishment and management of the account of the office. There are ministerial SI and ASI under the HA who function as Accountant, Pay bill Assistant, Cashier, Dealing Assistant etc. who are under the control of the Superintendent of Police.
- (g) One Inspector each are also posted as In-Charge of four other Branches of the office viz. Field Branch, Verification Branch, Technical Branch and Confidential Branch.

(iii) The procedure followed in the decision making process, including channels of supervision and accountability.

As the head of the office, the decision of the Sr. Superintendent of Police is final in cases concerning transfer and posting, distribution of works, granting of leave and sanctioning of rewards etc. Channel of supervision is as per the chain of command i.e. in order of rank in the official position. The accountability of each rank differs and it depends on posting and work assign to each.

The various functions of the Special Branch are governed by the Special Branch Manual, the Mizoram Police Manual, 2005, CCS and CCA Rules, Police Act and Cr.PC. Local laws, being in force in the State and other special laws as notified and amended from time to time by the Central and State Legislative Assembly.

III. CID (Crime)

(i) The particulars of its organisation functions and duties:

A. FUNCTIONS: The principal functions, among various others, of the State Criminal Investigation Department are as follows:-

- Providing information pertaining to crime and criminals to the State Government, Central Government, Director General of Police and other authorized bodies, as and when required.
- Preparation and publication of Criminal Intelligence Gazette.
- General watch and control over crime in the state as a whole, and assistance to the district police in prevention, investigation and detection of crime.
- Study of trends of certain types of crime e.g. professional crime, organised crime, grave and serious crime etc. with a view to devise and recommend appropriate prevention measures.
- Investigation of important, complicated and serious cases of crimes in which professional gang or criminals are involved and also of crimes having inter-district, Inter-State or international ramifications.
- Management and Maintenance of State Crime Record Bureau.
- Maintenance of handling and Photography Cell.
- Liaison with other Departments and Organizations of the State, the Criminal Investigation Department concerned with matters relating to crime and criminals.
- Timely preparation of periodical reports, returns and publications relating to the crime and criminals.
- Such other functions as may be assigned to the Branch by Director General of Police of the State.

B. ESTABLISHMENTS UNDER CID (CRIME):

- STATE CRIME RECORD BUREAU (SCRB): The main objective of the State Crime Record Bureau is management of crime records and acts as storing house of state crime records on stolen/recovered vehicles, missing person, motor vehicle accident report, crime statistics, management of computerization of crime records, etc.
- SCRB compiled crime statistics and data on accidental death and suicides within the state and submitted to NCRB, MHA, New Delhi for publication in 'Crime in India' and 'Accidental Death and Suicides in India'.
- SCRB collected and compiles data of motor vehicle accident report from all Districts. With a view to achieve Implementation on direction of Supreme Court Committee on Road Safety, Quarterly Report on Motor Vehicle Accident Report is submitted to Transport Department, Government of Mizoram. Annual Report on Motor Vehicle Accident is also submitted to Ministry of Road, Transport and Highways in a prescribed format for publication in 'Road Accidents in India'. In addition to the above, Motor Vehicle Accident Report is also furnished to Economics and Statistics Department, Government of Mizoram for publication in 'Statistical Handbook'.
- CRIME AND CRIMINAL TRACKING NETWORK AND SYSTEMS (CCTNS): Crime and Criminal Tracking Network and System (CCTNS) is a Mission Mode Project conceptualized and sponsored by the Ministry of Home Affairs (MHA) towards enhancing outcomes in Crime Investigation and Criminals Tracking; and in enhancing the efficiency and effectiveness of Police Departments in all States. It is proposed to achieve this through the adoption of the principles of e-Governance and creating a nationwide, networked infrastructure for supporting an ICT Technologies) (Information and Communication enabled state-of-the-art system. National Crime Records Bureau (NCRB) is the central nodal agency that would manage CCTNS, which would be implemented nation-wide. Law and Order being a State subject, States Governments and States Police Departments would play a leading role in implementing CCTNS. The Crime branch is the State nodal agency and has taken up necessary steps for its successful implementation.

- SPECIAL NARCOTIC POLICE STATION: Mizoram has a 727 kms long international boundary with two countries (404 kms with Myanmar, 318 kms with Bangladesh) and 284 kms of inter-state boundaries with three other states – Assam, Tripura and Manipur. Mizoram lies at the periphery of the Golden Triangle; Mizoram has always been a socio-cultural corridor because, historically as well as now, populations ethnically related to the residents of the state reside in the neighboring regions both foreign and within India. This creates favorable conditions for economic and financial interactions both licit and illicit and makes it both a destination as well as transit point for various goods including illicit narcotic drugs and psychotropic substances. Among the narcotic drugs known in Mizoram are substances such as Heroin, Opium, Ganja etc., while psychotropic substances include Amphetamine-Type Stimulants (ATS). Besides these, there are various synthetic drugs that are being abused and which causes socio-cultural problems among the youth. Hence due to its vicinity to 'Golden Triangle' area, one of the world's major opium producing regions, the drug trafficking situation in Mizoram has remained a matter of grave concern. The illegal cultivation of Opium/Cannabis has also added a further dimension to the Narcotics problems of the region. These illegal cultivation of illicit drugs has happen mainly in the eastern part of Mizoram along the Mizoram-Myanmar border. Most of the illicit drugs like Brown sugar, Opium, Heroine, Ganja etc. are coming mainly from Myanmar to India via Champhai (Mizoram) route. As a result of this, drug trafficker and drug peddlers spread across Mizoram and hence drug abuse is very common among the youths Mizoram. To counter these drug traffickers, smugglers etc. Government of Mizoram had established a Special Narcotic Police Station which has succeeded in detecting Drug traffickers to a large extent.
- STATISTIC BRANCH: Its main function is to gather information and secures intelligence on all matters which fall within its purview. The Branch deals with compilation and maintenance of the following records:
 - 1. First Information Reports from District Police.
 - 2. Daily Crime Reports from District Police
 - 3. Publication of Criminal Intelligence Gazette
 - 4. Fake Indian Currency Notes seizures
 - 5. Drugs seizures
 - 6. Arms and Ammunition seizures.
 - 7. State Crime Statistics.
 - 8. Wildlife Crime statistics
- ECONOMIC OFFENCES WING (EOW): The E.O.W. handles cases pertaining to investigation of crimes under Protection of Interest of Depositors Act, Prize Chit and Money circulation (Banning) Act and also economic crimes including Fake Indian Currency Notes(FICN) RACKETS eyc. It conducts enquiries on suspicious transactions provided by Financial Intelligence Unit, Verification and monitoring of operations of Non-Banking Financial Companies (NBFCs) and Unincorporated bodies(UIBs). 46(forty six) NBFCs and UIBs have been identified and verified in the State so far and action taken reports had been submitted to the Government. Enquires on online financial frauds and Bank Frauds are also conducted by EOW. EOW also conducted enquiry of various suspicious and sensitive cases received from Govt. of India (i.e., Ministry of Finance), Central Bureau Investigation(CBI), Central Economic Intelligent Bureau(CEIB), Ministry of Overseas Indian Affairs etc. and furnished report to the concerned authority.
- ANTI-HUMAN TRAFFICKING UNIT (AHTU): The Government of India, Ministry of Home Affairs proposed to establish Anti-Human Trafficking Units in 50% of the districts in the country. As instructed by the Government of India, 2 (two) Anti-Human Trafficking Units (AHTU) have been established in Mizoram at Aizawl District and Lunglei District. The Superintendent of Police CID (Crime) was appointed as state Anti-Human Trafficking Nodal Officer by Police

Headquarters, Mizoram vide order No.CB/PHQ/C/307/2010/75 Dt. 02/11/2010; the email ID of the Nodal Officer is ahtumizoram@gmail.com.

- **CYBER CRIME Police Station**: Cyber Crime Police Station became operational since 22nd May 2020 under the supervision of SP CID(Crime) with a total staff strength of 8 personnel and it was located at PHQ Khatla, Aizawl. Common cyber crimes in Mizoram are False rumour, Identity theft. Social Media/Sexual harassment/Bullying, Account Phising/Takeover, Phone Scam(Impersonating of various entities),Online shopping fraud Fake websites/search result Investment fraud, Sextortion etc.
- (ii) The powers nad duties of its officers and employees: The Criminal Investigation Department (Crime Branch) apart from the ministerial establishment consists of executive Police Officers mentioned below:-
 - 1. **Superintendent of Police, Criminal Investigation Department (Crime Branch):** He is the over all in-charge of the State Crime Branch under the close supervision of the DIG (CID). He is responsible for the efficient working of the branches placed under his charge. He is responsible for timely preparation of periodical reports, returns and publications.
 - 2. The Superintendent of Police, Criminal Investigation Department is assisted by one Additional Superintendent of Police, one Deputy Superintendent of Police and Head-Assistant and Accountant under him along with the requisite number of Ministerial staff of Sub-Inspector and Assistant Sub-Inspector. The strength of the ministerial staff depends on the volume of works.
 - 3. **Executive Staff:** The remaining executive staff of the Department consists of such number of non-gazette officers and as many as is determined by the State Government. These are divided into a number of branches, each of which are entrusted with the conduct of a particular tasks assigned to him. They are also directly responsible for action, movement, good conduct and efficient performance of duties on the part of their subordinates.
- (iii) The procedure followed in the decision making process, including channels of supervision and accountability.

All important decisions are taken with prior consent of the Superintendent of Police, CID(Crime).

(iv) The Norms set by if for the discharge of its functions:

All decisions in CID(Crime) are made through collective endeavors via step-by-step movement of files.

(v) The rules regulations instructions manuals and records held by it or under its control or used by its employees for discharging its functions:

All employees in the discharge of their functions adhere to all Mizoram Police Manual, Mizoram Police Act, Central Rules and Regulations, instructions as adopted by the Government of Mizoram

(vi) A statement of the categories of documents that are held by it or under its control:

The main procedure of processing is done through files opened for this purpose. Therefore, documents that are held by CID(Crime) are mainly files.

The CID(Crime) is not akin to other Departments of the State Government where policy or implementation thereof is required. Hence, arrangement contemplated under this sub clause is not in existence.

IV. MIZORAM POLICE RADIO ORGANISATION (MPRO)

(i) The particulars of its organisation functions and duties:

The Organisation is headed by one Sr.Superintendent of Police(Wrls) who is assisted by two Superintendent of Police(Wrls) , two Additional Supdt.of Police(Commn) and four Deputy Supdt.of Police(Commn) and the subordinate staffs are divided into four categories having different works as follows (a) Operator Trade (b) Cipher Trade (c) Radio Mechanic Trade (d) Fitter/Electrician Trade.

- a) Operator Trade: Their main job is to receive and transmit messages through Police Wireless Network.
- **b) Cipher Trade:** Their main job is to encode and decode classified messages received by the Police Wireless stations.
- c) Radio Mechanic Trade: Their main job is to maintain and repairding Wireless equipments held by the Organisation.
- **d) Fitter/Electrician Trade:** Their main job is to look after and maintaining of all the power sources used for Radio equipments to maintain a flow less communications.

Apart form the above Trades, Constable (General Duty) and Followers are held responsible for delivering messages received by the Message Control Center (MCC) as well as Police Wireless stations throughout the State.

The main duty of the Organisation is to establish and provide wireless communication for the Police in the prevention of crimes and detection of crimincals and for maintenance of law and order in the state. Besides this, the Organisation has also been rendering help to other Govt. departments by way of transmitting and receiving of their messages of all natures over wireless grids due to lack of other communication facilities in the state. We also not forget to extend help to public and other NGOs for providing wireless communications on their request as and when situation prevails.

(ii) The powers nad duties of its officers and employees:

Superintendent of Police (Wireless): He is the Head of Unit and looks after all the administrative works of the Organisation.

Additional Superintendent of Police (Communication): He assists SP(Wrls) in his job and takes the charge of SP(Wrls) during his absence on tour or leave period.

Deputy Superintendent of Police (Communication) : They assist SP(Wrls) and Addl.SP(Commn) in the administration and they are directly supervising the works and functioning of different branches and districts allotted to them by SP(Wrls) from time to time.

<u>Inspectors</u>: Each of the Inspectors was detailed to supervise the different branches and districts under the Organisation.

<u>Sub-Inspectors</u>: They are mainly posted to various branches and districts to assist the Inspectors in their supervisory works. Some of them are also posted to some important PR Stations such as Sub-Division as an Officer-in-Charge.

<u>Asst.Sub Inspectors</u>: They are mostly posted at PR Stations and given the charge of Offiver-in-Charge of the Stations.

<u>Head Constable</u>: They are posted in all the PR Stations within the State and did the actual job of maintaining of smooth Wireless Communication without a hitch

<u>Constable/Follower:</u> They are mainly utilised for delivering of Wireless messages received at Stations. Their services are also utilised for Orderlies, as well as Peon. They are also posted in all District Hqrs. and to some of the selected important PR Stations.

(iii) The procedure followed in the decision making process, including channels of supervision and accountability.

All important and major decision required making concerning policy matters were referred to Police Headquarters and only minor decision making is made by the Unit Head. Any proposal or scheme were initiated by the Dealing Assistant of the concerned branch from the concerned file which was routed through the branch head and to their respective G.O in charge who then put up the subject to the SSP(Wrls) for final decision and orders/instructions.

(iv) The Norms set by if for the discharge of its functions:

After making final decision for implementation of any policy or scheme by the Unit head, an instruction was mostly given in writing to the concerned person or Branch Head for its implementation.

(v) The rules regulations instructions manuals and records held by it or under its control or used by its employees for discharging its functions:

Each and every employees of the Organisation is governed by the rules and regulations lay down by Mizoram Police Manual and other related rules and regulation issued by the Govt. to its employees from time to time. Apart from this, the Radio procedure for the Police services issued by Govt.of India, Ministry of Home Affairs, DCPW was strictly followed in all the PR Stations form transmission/receiving and handling of all types of messages of different natures.

(vi) A statement of the categories of documents that are held by it or under its control:

The Organisation is holding both confidential and secret documents and the majority of the documents held by it are ordinary documents. The confidential and secret documents includes ACRs, Cipher code, PWCC and some messages transmitted and received in coded types.

(vii) The particulars of any arrangements that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof:

The Organisation is not akin to other Departments of the State Government where policy or implementation thereof is required. Hence, arrangement contemplated under this sub clause is not in existence.

V. TRAFFIC

(i) The particulars of its organisation functions and duties:

In the office of the Superintendent of Police, Traffic, Aizawl City, the S.P, Traffic is the head of the entire area covered by the jurisdiction of Aizawl City Traffic i.e Aizawl Municipal Corporation (AMC) Area. The overall administration of Police throughout the unit is vested on the S.P, Traffic and thus the general control, directions and supervisions are his main duties and function. He is the DDO of the establishment and is the sanctioning authority of all contingent expenditures.

The S.P, Traffic is also empowered with appointment of Constable and IV Grade, granting of rewards and kinds of leaves to the staff. He is the disciplinary authority and reporting officer for ACR of Gazetted Officers serving under him and is the accepting officer of the other lower Subordinate Officers including Service Sheets of constabularies. Provision of Section 112,115,116,117 of MV Act empowers S.P, Traffic to notify and issue order and notification regarding entry, no entry, dropping zone, no stopping zone, erection of traffic signs etc within the jurisdiction of Aizawl City Traffic Police. The S.P, Traffic in turn is under the direct supervision of DIGP (NR) Mizoram, who is under the administrative control of IGP (M) and DGP (M) is the whole administrative head of Police force.

(ii) The powers nad duties of its officers and employees:

Under the administrative control of S.P, Traffic there are stratas of ranks of Police Officer right from the Constabulary to Addl.S.P. The powers and duties of these Officers varied. They are governed by and exercise the powers and duties conferred by Cr.P.C, MV Act, Police ACT, Minor Act/bare Acts, Special and local laws, CCs & CCA rules and Financial rules. In connection of this the Mizoram Compendium of law as update from time to time may be consulted. Under the provision of MV Act, Central Motor Vehicle Rules the officers and men under Traffic Unit have the power to seized Traffic rules violators, detain seized vehicles/documents etc. as and when necessary. A Police Officer not below the rank of Asst.Sub-Inspector of Police have the power to compound any Traffic rules violators on the spot by issuing a compounding challan duly counter signed by him/her.

The different stratas of Officers and other employees that function under the administrative control of the Superintendent of Police, Traffic with each main function and duties are:-

- (a) <u>Addl. S.P Traffic</u>:- There is one post of Addl. SPs in Traffic Unit, the assigned duties are Establishment Branch, MT Branch and Reserved Branch, also work as DDO for SP Traffic Office, Traffic Clothing Store, Traffic arrangement in connection with VIP/VVIP etc.
- (b) <u>Dy. Superintendent of Police and Office Staff</u>: There is one Dy.SP post in Traffic Unit. He/She is in-charge of Field Duty throughout the jurisdiction of Traffic Unit. He/She is supervising Officer, supervising and taking care of the works of Traffic Station, Aizawl. The Dy.SP, Traffic is assisted by Inspector, SI or ASI, Literate constable, typist and one or two other H.C or constables including a Driver.
- (c) <u>Officer-in-Charge</u>, <u>Aizawl Traffic Station</u>: He is responsible for the overall functioning, administration and management of the Traffic Station. There are number of other Officers under the control of Officer-in-Charge. The general duty of Officer-in-Charge is the effective working and management of the Police subordinate posted to Traffic Station; prevention and detection of traffic rules violators, effective management of Aizawl City Traffic. He is to constantly in liaise with Dy.SP, Traffic and S.P, Traffic and take supervision and instruction effectively.
- (d) <u>Reserve Officer and other Officers with Constabulary in Reserve Office</u>:- Reserve Officer(R.O) is in-Charge of Reserve Office which is one of the branches of S.P, Traffic Office. Reserve Office is the charge of an Inspector who has One Sub-Inspector and other

lower ranking Police for his assistance. He is concerned mainly with the discipline and general management of the whole Traffic force. He and his staff are responsible for maintenance of Service book of all Traffic Staff excluding G.Os and Ministerial staff, maintenance and proper custody of Office equipments and monitoring of Official correspondences. The Reserve Officer of Traffic Unit is responsible for maintenance of records of arms and ammunitions, issue and records of all clothing and equipment to Traffic police personnel's and equipments to Traffic Station and other branches of S.P, Traffic Office.

- (e) <u>Motor Transport Officer</u>:- Inspector rank is placed as in-charge of M.T Branch in Traffic Unit. Under him Driver Grade –I, Grade –II, Grade-III and other Constables are posted. Their duty and responsibilities are to look after the entire fleet of Aizawl City Traffic police vehicles. The other duties are drawing and issue of POL to vehicles and getting the defective vehicles repaired.
- (f) <u>Head Assistant</u>:- A ministerial Inspector placed in the charge of all ministerial staff deals the general establishment and account of the SP's Traffic office. Two Ministerial Inspectors, two Ministerial Sub-Inspector, one Ministerial ASI function as Accountant, Pay Bill Assistant, Cashier, Dealing Assistants under the direct supervision of S.P, Traffic and Addl. SP, Traffic.
- (g) <u>Personal Assistant to SP</u>:- S.P, Traffic office has a personal Branch called Personal Branch which is taken care of by one Stenographer Sub-Inspector who is assigned as PA to SP, Traffic.
- (iii) The procedure followed in the decision making process, including channels of supervision and accountability.

All immportan decisions are taken with prior consent of the Sr. Superintendent of Police.

(iv) The Norms set by if for the discharge of its functions:

All decisions in Mizoram Police are made through collective endeavours via-step-by-step movement of files.

(v) The rules regulations instructions manuals and records held by it or under its control or used by its employees for discharging its functions:

All employees in discharge of their functions where to all Central Rules and Regulations, Instructions adopted by the Govt. of Mizoram including Mizoram Police manual, Police Act and other subsidiary Rules and Regulations.

(vi) A statement of the categories of documents that are held by it or under its control:

The main procedure of processing each case is done through files open for this purpose. The documents that are held by the Department are mainly files & Registers and Vouchers.

VI. POLICE TRAINING SCHOOL


(i) The particulars of its organisation functions and duties:

Police Training School initially named Police Training Centre, Mizoram at the time of establishment in 1973 as a part of training wing of 1st Battalion MAP at Lungverh, is the one and only training Institution for Mizoram Police and continued as such till 31st march, 1986. Later, the Police Training Centre was officially recognized and officially functioned w.e.f 1st April,1986 with the sanction of the President of India vide Government of India, Ministry of home Affairs Letter no.13034/21/97-MZ Dated. 8.11.1985. After considering various facts and circumstances, the Training Centre was shifted to Thenzawl in the year 2011 and declared into full fledged Training centre by Governor of Mizoram vide Memo no. 11013/46/2011-HMP dated 4.5.2011. Later, the Governor of Mizoram declared as Police Training School vide Memo no.A 11013/1/2012-HMP dated 20th December, 2012.

The Police Training School was established keeping in view that various training Course to be carried out for Mizoram police inside Mizoram. Main activities include the following:

- 1. Impart 45 weeks basic training to the directly recruited constable's driver/constable/firemen.
- 2. impart 3 months basic training to the directly recruited h/c operators of Mizoram police radio organization.
- 3. impart 3 month sbasic training to the directly recruited Assistant Sub-Inspector (ministerial).
- 4. Design and offer a number of different types of in-service training for police personnel of the rank of constables to sub-inspectors.
- 5. Compile documents and analyze the available literature directly and indirectly to police training.

There is a systematic hierarchy in Police Training School as is in other police unit all over Mizoram. The Hierarchy/Functional Chart is as mentioned below.



As mentioned above, Principal, who is of equal rank with District Superintendant of Police and Commandant of Armed Battalion is the head of the unit and he is assisted by Vice Principal and Assistant Principals, who are of equal rank with Additional S.P and Dy.SP of district police and Dy.CO and Asst. Commandant of Armed Battalion respectively. Beside these Gazetted Officers, different branches of the unit are headed by sub-ordinate officers who are appointed by Principal for the smooth and efficient functioning of the unit as and when required.

As highlighted earlier, the main functions and duties of Police Training School is to give training to police personnel of Mizoram and its mission statement is "to impart methodical training to police personnel, to improve the quality and modernize the training, updating the knowledge and professional skills, to meet the emerging situation and complex problems, effectively, efficiently, tactfully and place the institution as a school of excellence in the field of police training and do all these with integrity, impartiality commonsense and sound judgment".

(ii) The powers nad duties of its officers and employees:

The powers and functions of officers and employees of PTS unit may be summarized as below

Principal:

Principal, PTS is the head of the unit. He shall enjoy the powers and privileges of the head of office. He shall be responsible for all matters pertaining to the Police Training School administration, training and other related matters.

Vice Principal:

A Vice Principal in the rank of Additional Superintendent of Police shall assist the Principal, Police Training College in all aspects of the work. His main duty is to look after the Indoor and Outdoor Training. He should supervise the Outdoor Training at the field and also attend various Indoor Classes to be fully acquainted with the individual Outdoor and Indoor Instructors.

Assistant Principal:

As per Mizoram Police Manual, there has to be Assistant Principal Indoor and Outdoor who shall be in-charge of Indoor and outdoor training and shall co-ordinates accordingly. Various training activities as well as administrative functions shall be carried out as directed by the Principal.

Chief Law Instructor:

All indoor matter is co-ordinated by the Chief Law Instructor of the rank of Inspector who shall be over all in charge of Indoor Subjects under the guidance of Assistant Principal. Training Syllabi for various courses shall be designed and get it approved by the Principal.

Chief Drill Instructor:

The Chief Drill Instructor of the rank of Inspector, who shall be over all in charge of Outdoor matters and specialized Instructors in the rank of Sub-Inspector for Outdoor Training to teach subjects like Weapons, Map reading, Field craft and tactic, etc. he shall ensure various trainings are imparted by instructors from the rank of Naik to Sub-Inspector giving their best capabilities.

Reserve Officer:

The Reserve Officer is responsible for dealing with:

- 1. All correspondences in the Reserve Office.
- 2. He shall receive, examine petitions and applications and lay them before the authority.
- 3. He shall issue leave certificates of men proceeding on leave and check the leave certificate on return.
- 4. He shall make himself fully acquainted with all the registers and files of the office.
- 5. He shall ensure that the Service Books are maintained up to date and deal with all correspondences relating to service matters.

Quarters Master:

The quarters Master is responsible for dealing with:

- (1) He shall maintain all relevant registers, cash books, files and other important records.
- (2) He shall prepare statements of arms and ammunition and other correspondence.
- (3) He shall ensure safe custody of all Government property kept in the store, their proper storage to prevent damage and deterioration, take care of inflammable materials an proper fire fighting arrangements are made.
- (4) He shall maintain a Building Register and keep a record of all the buildings in the unit area and ensure that quarters are maintained.
- (5) He shall supervise the on-going constructions in the unit and ensure that constructions are being done according to the plan.
- (6) He is entrusted to look after unit generated electric power and water distribution in consultation with higher authority.

Head Assistant:

A ministerial Inspector placed in the charge of all ministerial staff deals the general establishment and account section of the Principal's office. Service matters of GO's and Medical Staff are handled by Ministerial staff under the supervision of Head Assistant at the same time of dealing other important correspondence and file works. Two Ministerial Inspectors, three Ministerial Sub-Inspectors, two Ministerial ASI's function as Accountant, Pay Bill Assistant, Cashier, and Dealing Assistants under the supervision of Principal.

Motor Transport Officer:

The Motor Transport Officer (MTO) is responsible for :

- (1) Maintenance of the all vehicles of the Unit to keep them in tip-top conditions. The Motor Transport Officer will discharge his responsibilities under the supervision of his superior officers.
- (2) He shall supervise the work of his subordinates in charge of Petroleum, Oil, Lubricants and Stores and shall ensure correctness of stores by periodical inspection and monthly physical verification of motor parts and other articles in stock.
- (3) He shall be responsible for the daily and weekly maintenance of the vehicles.
- (4) The control and maintenance of discipline of the drivers and mechanics etc. are the responsibility of the Motor Transport Officer.

Medical Officer:

Presently, PTS is having Medical Officer deputed from H&FW Department. M.O is another important officer who take the charge of Medical Infirmary (M.I) of the unit. He shall be responsible for the physical health of the staff of the unit. He shall be the entire time ready for emergency relating to the medical health/fitness of trainees or staff. He shall supervise the work of his/her staff and try to make necessary medicines and equipments available all the time.

(iii) The procedure followed in the decision making process, including channels of supervision and accountability.

The Principal, who is the head of unit makes decision in all the cases pertaining to this unit. His decision in maintenance of unit area, buildings and quarters, training matter (in consultation with DIG-Trg), account matters and disciplinary proceeding etc. is unchallengeable except in some special cases. Distribution of works is also made as per his decision.

The channels of supervision could not be deferred from the chain of command which is practiced in the discipline force viz. *In order of rank*. The accountability of each rank differs and depends on the post he holds or work assign to them. Meanwhile, as Police Training School is one of the units of Mizoram Police, it may not be appropriated to apply transparent governance in unit administration but, in case of information is asked or question is raise relating to the unit, SPIO and SAPIO who are appointed by higher authority may publish or give information accordingly.

(iv) The Norms set by if for the discharge of its functions:

As a government servant, norms set by CCS(CCA)conduct rules, Financial Rules and other local laws, rules and other special laws as notified and amended from time to time by both that central and state legislator are used for the discharge of functions. Besides, as a discipline force, separate norms set by Cr. P.C, IPC, Indian Evidence Act, different Minor Act are adopted along with Mizoram Police Manual,2005 and Mizoram Police Act,2011(Act no.3 of 2012). Further, the Mizoram compendium of laws as made up to date from time to time may also be referred in this regard.

(v) The rules regulations instructions manuals and records held by it or under its control or used by its employees for discharging its functions:

There is no separate rules, regulations, manual and records held by this unit. But, as a police unit and mentioned earlier, the employees of this unit are automatically governed by Mizoram Police Manual, 2005, Mizoram Police Act,2011(act no.3 of 2012) and CCS(CCA) conduct Rules, Financial rules, Local and other special laws. Besides, for discharging police duties and functionaries, Cr.P.C , IPC, Local and Special laws, numbers of minor acts and other regulations, instructions and bills made and issued by the central and state Government, including rulings of both Supreme Court and High Courts of India in connection with both criminals and civil suits, which were enforced time to time in India.

(vi) A statement of the categories of documents that are held by it or under its control:

Documents/Correspondences coming from the Government of Mizoram and the Police Headquarter, Mizoram are well maintained by the concerned branch of the unit and separate files are opened for the said documents for further necessary action and strict compliance.

There are some committees constituted at the unit level for the purpose relating to the function mentioned against each committee.

1. **GPF board:**

As instructed from PHQ, Aizawl Mizoram, GPF board (unit level) was constituted on 26th April, 2016. The objective of creation this committee is to create fair and transparent system in disbursing GPF withdrawal. As such, selection of person and amount to be disbursed are selected /prepared without any prejudice and biasness and thus, moved to the Principal for approval.

2. Canteen committee:

As PTS Unit is having dry and wet canteen, it is required to have a committee to look over and maintain its account. Purchase of canteen requirement as per the needs of staff and families. The committee members are appointed by Principal and Audit may also be done as and when required.

3. **DPC** board for driver:

DPC board for driver promotion has been constitute whenever there is eligible Driver for promotion to the next rank and in this board, all G.O's are ex-officio under the chairmanship of Principal with MTO and R.O as the member. The committee will consider whether the eligible driver is fit or unfit for promotion to the next higher rank.

4. Training Mess committee:

As PTS is the one and only training school, there are trainees of different rank throughout the year. As the training mess is managed by unit from the fees collected from trainees, a mess committee is constituted under the chairmanship of Vice Principal with one or more representative from the trainees. This committee functions and its account have to be transparent and can be accessed by the trainees if they have any queries.
