TERMS & CONDITIONS:-

1. The quotation shall consist of **'Technical Bid' and 'Price Bid'** as follows.

Technical Bid: It shall mention: (1) Name of the item as it is written in the tender notice, (2) Brand of the item if the quality is branded and (3) Name, address and contact number of the firm. It shall also enclose a copy of GST Registration Certificate and also refer to this tender notice. It shall also mention that the firm fully agrees with the terms & conditions laid down in this tender notice. Non-Tribal bidders should enclose a Court Fee Stamp worth not less than Rs. 7.50/-. It shall be enveloped properly. The envelope shall bear a superscription, 'Technical Bid 2024-25'.

A superscription, 'QUOTATION FOR SUPPLY OF UNIFORM ITEMS FOR MIZORAM POLICE FOR THE YEAR, 2024-25' shall be given on the envelope and addressed to Director General of Police, Mizoram, Aizawl. The envelope shall then be sealed properly.
- 3. There shall be no correction or overwriting in the quotation. Quotation once submitted shall be final.
- 4. The quotation shall be evaluated on Quality cum Cost Based Selection (QCBS).
- 5. Holders of valid MPSP certificate or its equivalent will be given 15% preference as per Rule 8 (2) of the Mizoram Preferential Store Purchase Rules, 1994 provided that the Technical Committee is satisfied that the sample is manufactured by the firm.
- 6. Each quality offered shall come with 2 (two) samples. The samples shall bear the following information on tags firmly attached to them.
 - 1) Name of the firm.

2) Name of the item as it is written in this tender notice (Sample number shall be given if more than one quality are offered for one item)

- 3) Brand of the quality, if branded.
- 4) Name of the tenderer.
- 5) Contact number of the tenderer.
- 6) Year i.e. 2024-25.
- 7. Quotations without complete samples will not be valid.
- 8. Price for the item shall not be written in the tag attached to the sample.
- 9. Samples shall conform to the technical specifications given in the Annexure to this tender notice.

- 10. Samples for cloths shall be at least ½ meter both in length and width and also bear brand, model and code no or code name of the quality, woven along the monogram.
- 11. Conditional tenders will not be entertained.
- 12. Samples will be subjected to technical examination. Samples which do not meet the technical specifications will be rejected at this stage.
- 13. Government of Mizoram shall have the right to increase or reduce the quantities mentioned in the Annexure, if necessary or appropriate for any reasons.
- 14. Selected firms, which are not exempted, shall have to make Security Deposit in favour of Director General of Police, Mizoram at 5% of the total value of the supply contract and submit the same to this office. Without submission of Security Deposit, the Earnest Money Deposit may be forfeited, and Supply Order shall not be issued to them. The selected firms shall have to submit the Security Deposit and obtain Supply Order within 15 (fifteen) days from the date they are informed by any means to do so.
- 15. Selected firms, which are exempted from Security Deposit, shall also have to obtain Supply Order within 15 (fifteen) days from the date they are informed by any means to do so.
- 16. If any selected firms withdraw after finalisation of the selection process, they shall be liable to be blacklisted and their deposits forfeited.
- 17. It shall be binding on the selected firms to deliver all the ordered quantities conforming to the approved qualities to the Police Central Store within 90 (ninety) days from the date of issue of supply order.
- 18. The Security Deposit will be returned to the supplier only on satisfaction of this office with the supply.
- 19. Payment will be made only after receipt and acceptance of the supply. No advance payment will be made. Claim for interest will not be entertained in the event of delayed payment.
