As approved by the Government of Mizoram vide No. G-20017/11/2019-HM dated 18.07.2024, bids are hereby invited from registered firms for supply of the following Brass Band Instruments for Mizoram Police.

TERMS & CONDITIONS:-

- Names and products of the items must be mentioned clearly.
- Rate for each item must be mentioned both in figure and word.
- The rates must be inclusive of GST.
- Transportation charge must be mentioned separately.
- This office shall have the right to collect the items without paying the transportation charge.
- GST Registration Certificate shall be enclosed with the bid.
- Bid security @ 2% of the total quoted value in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any Commercial Banks or payment online in an acceptable form, pledged to DGP, Mizoram shall be enclosed with the bid. The bid security of unsuccessful bidders will be returned after final acceptance of bid and signing of contract.
- The bid security taken from the bidder may be forfeited on any of the following grounds.
 - (1) When the bidder withdraws or modified his bid after opening of bids;
 - (2) When the successful bidder fails to deposit the performance security after fifteen days of the issues of offer of contract.
 - (3) When the successful bidder fails to sign the contract in accordance with Bidding document.
 - (4) To adjust any dues against the bidder from any other contract with the procuring authority.
 - (5) If the bidder breaches any provision of code of integrity prescribed for bidders in rule 64 of the Mizoram Public Procurement Rules, 2020.
- If the firm is exempted from bid security, a certified copy of the document to that effect shall be enclosed.

10. Successful bidder shall submit performance security @ 5% of the supply contract in any of the following forms.

- 1) Banker Cheque of a scheduled bank.
- 2) National Saving Certificates and any other script/instrument under National Saving Schemes.
- (6) Bank guarantee. It shall be immediately got verified from the issuing bank. Other conditions regarding bank guarantee shall be same as that mentioned in the rule for bid security in the Mizoram Public Procurement Rules, 2020.
- 3) Fixed Deposit Receipt of a scheduled bank. In such a case, the bidder shall furnish an undertaking from the bank or Post Office/NSC to make payment/premature payment of the security to the Procuring Authority on demand without requirement of consent of the bidder concerned. In the event of forfeiture of the FDR or NSC, the FDR will be forfeited along with the interest earned.

Performance security shall remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations-maintenance period/defect liability period.

11. Grievances, if any, shall be heard and decided upon in Aizawl only.
