HUGE SEIZURE OF METHAMPHETAMINE

In yet another huge success in the relentless 'War On Drugs', yesterday on 29.8.2024 (Thursday) at 2:30 PM, a team of Special Narcotics PS under CID Crime and 2nd Assam Rifles while conducting joint operation within Bawngkawn Aizawl area recovered and seized 9.726 Kgs of suspected Methamphetamine with an estimated value of Rs.1,26,43,800.
