Dear Shri Anil,

The National Investigation Agency was created in 2008 with the mandate to investigate and prosecute terror offences. Over the last few years, the mandate of the NIA has expanded to investigate cases related to Cyber Terrorism, FICN, sale of Prohibited Arms, Explosive Substances and Human Trafficking.

2. NIA has countrywide jurisdiction with Headquarters located at New Delhi and 21 Branch Offices at Hyderabad, Lucknow, Guwahati, Mumbai, Kochi, Kolkata, Jammu, Raipur, Chandigarh, Chennai, Ranchi, Imphal, Ahmedabad, Bhopal, Bengaluru, Bhubaneshwar, Patna, Jaipur, Dehradun, Dimapur and Visakhapatnam.

3. The posts in the NIA at various levels are being filled primarily on deputation basis as per the standard terms and conditions laid down in DOP&T OM No. 6/8/2009-Estt (Pay.II) dated- 17.06.2010 and as amended time to time. The initial tenure of deputation in the NIA will be 03 years, which is extendable upto 07 years.

4. It has been experienced that the State Police personnel having experience of working in State Police, State ATS or Crime Branch are better equipped in conducting investigation into terror and other offences. Currently sizeable number of vacancies exist in NIA in the rank of Sub-Inspectors, Inspectors, DSPs and ASPs.

5. It may be added that the eligibility criteria entails induction in the above mentioned ranks of officials holding analogous ranks. However, deserving candidates can be taken even at one rank higher. Officials selected for deputation to NIA are entitled for Special Security Allowance (SSA) @20% of basic pay, in addition to other admissible allowances.

6. I would be grateful, if you could kindly sponsor names of officials of above mentioned ranks who have worked with ATS or Crime Branch in the State Police for their induction in NIA on deputation basis.
