# SEIZURE OF HEROIN BY JOINT TEAM OF CID (SB) & SPECIAL NARCOTICS PS

Acting on reliable inputs, a joint team of CID (SB) and Special Narcotics Police Station under CID (Crime) launched an operation since yesterday (18.09.2024) and intercepted one vehicle (Bolero B/R No. MN05A-9339) this morning on 19.09.2024 at around 07:45AM near Bawngkawn Traffic Point. Upon conducting search of the vehicle, the team recovered and seized 378 grams (30 soap cases) of suspected heroin valued at Rs. 11,34,000/- from the illegal possession of the driver of the said vehicle, Lenminpao (34) s/o Thangneineh of Churachandpur, Manipur and his passenger, Haumingsen Suantak (28) s/o Thangneineh Suantak of Churachandpur Manipur.

Special Narcotics PS Case No.37/24 dt 19.9.24 u/s 21(c)/25/29(1) ND&PS Act was registered for further legal action and investigation on backward and forward linkages.
