### **ANOTHER HUGE SEIZURE OF METHAMPHETAMINE**

This morning on 3.09.2024 at around 2:45 AM, acting on specific input, Special Narcotics PS team under CID Crime conducted operation at Lungverh, Sakawrtuichhun area. The team recovered and seized 41.234 Kgs of suspected methamphetamine with an estimated value of Rs 5,36,04,200.

In this connection, 5 (five) persons namely – (1) Edenthara (27), s/o Tlangthanga, Rihkhawdar, Myanmar (Present Address – Zemabawk), (2) Rochharliana (38) s/o Sangtinkulha, Hruaikawn, Champhai District, (3) Vanlalvunga (47) s/o Vanlalmawia, Khuangleng, Champhai District, (4) Nasir Uddin (34) s/o Junab Ali, Karimganj, Rupargool District, Assam and (5) Anurul Haque (37) s/o MD Abdul Rasid, Baghan, North Tripura were arrested.

Special Narcotics PS Case No. 35/24 Dated 3.09.2024 u/s 22(c)/25/29(1) ND&PS Act was registered for further legal action and investigation on backward and forward linkages.




