#### SEIZURE OF HEROIN AND METH BY ZOKHAWTHAR POLICE

On the night of 02.09.2024 at around 10:25PM, Zokhawthar Police Station team while conducting random checking at the outskirt of New Hruaikawn Village halted one vehicle (Bolero) B/R No. MZ-01AA 3824 plying from Bulfekzawl towards Champhai on suspicious ground. On conducting thorough checking of the said vehicle, they recovered and seized 2.557 Kgs (220 Soap Cases) of suspected heroin with an estimated value of ₹7,671,000 and 5.742 Kgs (50500 tablets) of suspected Methamphetamine with an estimated value of ₹7,464,600 from the joint possession of David Rosangliana (30) s/o Lalthangkhuma and Lawmsangzuala (27) s/o Lalremruata, both of Bulfekzawl Village.

Zokhawthar PS Case No.80/24 Dated 03.09.2024 u/s 21(c)/22(c)/25/29 ND&PS Act was registered for further legal action and investigation on backward and forward linkages.
