### ADVISORY ON FORGERY

On 25.10.2024, an information was received by Vaivakawn PS from reliable source reporting that one male person Lalneihpuia of Chawhhmun, Aizawl (Ph. No. 8119941667) posted on social media stating that he can make a certificate and in this regard, discreet enquiry was immediately conducted. During enquiry, SI C. Lalremruati with party proceeded to Chawlhhmun, Aizawl and apprehended the said person Lalneihpuia (27) of Chawlhhmun, Aizawl) and produced him at the PS. After careful and sustained interrogation, he confessed his guilt by disclosing that from the month of August 2024, he had started making duplicate/false certificates using his mobile phone Oppo A71k (Model CPH1801). He further admitted that he had made about 20 nos. of duplicate/false certificates including HSSLC/HSLC Marksheets. Certificate, driving license and Mizoram University Grade Card at the rate of Rs. 2,000, without license/authorization to make any documents/certificates from competent authority. His mobile phone was seized and the said accused Lalneihpuia (27) s/o Lianchungnunga of South Vanlalphai, Hnahthial District (Present Address - Chawlhhmun, Aizawl) was arrested. Vaivakawn PS Case No. 151/24 Dt. 26.10.2024 u/s u/s 336(2)/336(3) BNS was registered for further legal action and investigation.

Forgery is a serious criminal offense that involves falsely making, altering, or imitating and using false documents such as educational degrees, professional certifications, signatures, etc. for deceitful purposes. Mizoram Police cautions and urges the general public to be wary of such fraudulent practices and to refrain from any involvement in such forgery practices, and also to exercise extreme cautions when acquiring important documents.
