SEIZURE OF HEROIN AT VAIRENGTE

On the evening of 19.10.2024 at around 5:00PM, Vairengte Police while conducting checking at Vairengte Police check gate intercepted one vehicle (Maruti A-Star B/R No.MZ05A/0712) proceeding towards Silchar from Kolasib, driven by Khundra Pam (55) s/o K. Tomba of Venglai, Kolasib along with his friend Lalchhanchuaha (38) s/o Lamthanga (L) of Venglai East, Kolasib. On thorough checking of the vehicle, recovery and seizure of 239.18 grams (20 soap cases) of suspected heroin with an estimated value of Rs. 7,17,540 was made from their possession. Unfortunately, the driver and owner of the vehicle Khundra Pam (55) s/o K. Tomba of Venglai, Kolasib fled away to an unknown destination at the time of interception.

Vairengte PS Case No.49/24 Dated 19.10.2024 u/s 21(b)/25/29(1) ND&PS Act was registered for further legal action and investigation on backward and forward linkages.
