SEIZURE OF METHAMPHETAMINE

Our persistent efforts in our fight against drugs has led to another big seizure of drugs. A team of Mizoram Police comprising of CID(SB) and Special Narcotic PS staff while conducting operation last night at Zemabawk Beraw lui intercepted one vehicle (Scorpio B/R No. MZ01 AB 5750) coming from Zokhawthar, recovered and seized 30 packets of suspected Methamphetamine hidden in a false chamber at the middle row and rear row seats of the vehicle, weighing 29.289 Kgs with an estimated value of Rs 380.757 lakhs in the local market from Tlangthanmawia (30) s/o Lalrampana of Tahan, E- Group, Myanmar on 28.11.2024 at 12:30 AM at Tawngtai Mual, Zemabawk. Special Narcotic PS No.47/24 Dt. 28.11.2024 us 22(c)/25 ND& PS Act, 1985 r/w 14 A Foreigners Act was registered for further legal action and investigation on backward and forward linkages.
