3. The last date for submission of entries is 30th April, 2025.

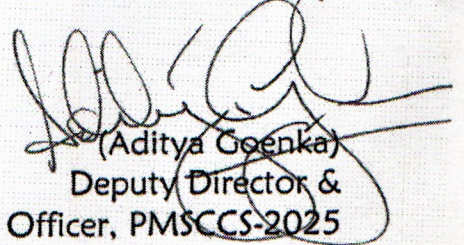

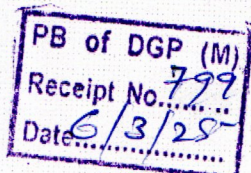
It is requested to consider the matter on priority, keeping the significance of the Competition in mind.

PRIME MINISTER'S SILVER CUP CASE STUDY – 2025
COMPETITION RULES

1. The Sardar Vallabhbhai Patel National Police Academy will hold an all-India Annual Competition for the award of the Prime Minister's Silver Cup in Case Study Format.
2. The Prime Minister's Silver Cup shall be awarded for the best Case Study. The topic for the Competition for the year 2025 shall be:
"Core Policing as the Bedrock: Technology as an Enabler or Force Multiplier"
3. The competition is held annually and shall be open to all serving police officers / personnel of India including those serving in Central Police Organizations in India and abroad provided that an officer who has won the first prize for two successive years shall be debarred from taking part in the Competition for a period of three years at a stretch following the year in which the first prize was won by him for the second time.
4. The Committee of the Competition shall consist of the following members to be invited by the Director of Sardar Vallabhbhai Patel National Police Academy:-
 - (i) An eminent jurist.
 - (ii) An eminent educationist.
 - (iii) An eminent journalist / public man.
 - (iv) One serving Inspector General of Police.
 - (v) A nominee of the Prime Minister's Office.
5. Any question as to the eligibility of any Competitor shall be determined by the Committee of the Competition.
- (6) (i) The document must be submitted in the **Case Study Format (Attached as Annexure – A)**
(ii) Case Study must be submitted in **ENGLISH**
- (7) **The document must be submitted by registered post / courier and email.** A letter containing details about the competitor's name, rank and the official address should also be submitted along with the Case Study.
- (8) The Committee reserves the rights to disqualify any entry, which fails to conform to these rules. If any default comes to the notice of the committee after a prize has been awarded, the committee reserves the right to take such action against the defaulter as may deem fit.

- (9) The Case Study may be submitted by the leader or any member of the team who has tackled the issue, to the Director General of Police / Head of Central Police Organization concerned. After due screening at the State / Central Police Organization level, the Director General of Police / Head of the Central Police Organization will forward **a maximum of three Case Studies** to the Convener of the Committee of the Competition for final selection of the best Case Study.
- (10) The decision of the Committee shall be final. The Case Study submitted for the competition and adjudged as the prize-winning entry may be published by the Director of the Sardar Vallabhbhai Patel National Police Academy and the copy right for such published Case Study shall vest with the Director. The Case Studies that have not been accepted will not be returned to the competitors.
- (11) The Silver Cup is a running trophy & will be returned to the Sardar Vallabhbhai Patel National Police Academy. The Officer adjudged to have submitted the best Case Study will be given a prize money of Rs.10,000/- and a replica of the Silver Cup. The Case Study considered next in order of merit will be awarded Rs.6,000/- and Rs.4,000/- respectively, along with medals and certificates of distinction. The Cup and the First Prize will be awarded on the occasion of the **Annual Passing Out Parade** at the Academy. Winner may be asked to briefly present best practices as part of the DGP conference.
- (12) The Case Studies shall be addressed by the Director General of Police / Head of Central Police Organization to the Director, Sardar Vallabhbhai Patel National Police Academy, Hyderabad.

CASE STUDY FORMAT**PART - I**

- a) Title
- b) Domain / Sub domain
- c) Brief description of the case
 - (i) The abstract should be no more than 100 words and it should outline the structure of the proposed article. The following to be adhered to:
 - Write in third person
 - Write in past tense

PART - II

- a) Background / Problem Statement / Case description
- b) Interventions
- c) Results / Outcome
 - Should be in past tense
 - It should be written as concisely as possible
 - Avoid speculative or interpretative words
- d) Discussion / Conclusion
 - Summarize your key findings
 - Give your interpretations
- e) Challenges faced
- f) Implication
 - (i) Why should present day police officers need to know about it?
 - (ii) How can this idea be applied today?
 - (iii) What is important, useful or new about the efforts taken in this case.
- g) Exhibits – Start on new page, ideally only one exhibit per page.

Exhibit 1 – Text / Data / Visuals / Table

- h) References
 - *Source of the information about the experience / Best Practices in alphabetical Order
- (l) Designation & full address

FORMATTING FOR CASE STUDY

1. The maximum length of the submission is 20 pages (including title page and all figures, graphs, tables, appendices, and references).
2. 12 Point with font Time New Roman with the following
 - (a) Double spacing
 - (b) Margin with 2.5 CM all around
 - (c) Page setting 5" X 11"
 - (d) References may be single spaced
3. The entire paper submission (title page in Title Case, Abstract, main text, figures, graphs, tables, references etc) must be in ONE document using one of the following formats.
 - (a) Portable document Format (.PDF)
 - (b) Microsoft word (.doc, .docx)
4. Number the pages of the documents
5. Make sure that the file or documents uploaded is virus -free before submitting.
